### **2. OUTLINE**

These Terms of Reference outline the minimum Scope of Work for which the Service Provider (Contractor) is responsible. It defines key activities and what the Contractor is responsible for delivering i.e. the required outcomes as a result of the fencing activities.

### **3. BACKGROUND**

Winnie Madikizela Mandela Local Municipality falls within the jurisdiction of Alfred Nzo District of the Eastern Cape Province.

The municipality has a valid NERSA approved distribution license to the residents of Bizana. Municipality installed streetlights in Main street and Thompson Avenue with the intentions of keeping our streets safe from crime. These streetlights have been damaged and poles hit by turning trucks which resulted in most of them not functional due to damaged cables. Municipality therefore has a budget to repair damaged cables and replace all the poles that were hit by cars and trucks.

## **SCOPE OF WORK**

- a. Supply, deliver and install 16mm x single phase armored cable to replace the damaged cables.
- b. Conduct fault finding and repair work on streetlight circuits.
- c. Reclaim all damaged steel poles on the circuit.
- d. Excavate and plant new steel poles.
- e. Replace circuit breakers.
- f. Design control circuits and supply all accessories for each light circuit.
- g. Replace damaged LED Streetlight fittings with built in Nema photocell.
- h. Excavate 1m deep trenches and lay 16mm cable.
- i. Test and commission all circuits including controls
