1. PURPOSE

Nongoma Local Municipality seeks to source a panel of service providers who will supply municipal vehicles with fuel as and when required.

2. BACKGROUND

The Municipality has a fleet of vehicles that are utilized by municipality for service delivery to the community. Such vehicles needs fuel on daily basis and as such a panel of services providers will provide these vehicles with fuel.

3. SCOPE OF SERVICE

To provide petrol and diesel .

4. AVAILABILITY

The service provider will be required to provide diesel and petrol 24hours a day and 7 days a week.

5. DURATION

The duration of the contract shall be the minimum of three (3) years from the date of appointment.

The probation period for the service provider shall be six (6) months. If the municipality is not satisfied with the services of the service provider within the probation period, then it terminates the services of the service provider and appoints another service provider. The service provider will be evaluated based on performance atleast twice a year and prior arrangement will be made regarding such evaluation date.

6. EVALUATION OF THE BID

The following evaluation method will be used:

- After the closing date of the bid invitation, an appointed bid evaluation committee of Nongoma Local Municipality will evaluate the proposals of the bidders.
- The committee will individually evaluate each of the bid proposals received against the approved criteria as stated below.
- All proposals submitted will be evaluated on two (2) categories:
 - Functionality (technical content)
 - Specific goal

Bids are evaluated in accordance with the Preferential Procurement Policy Framework Act (MFMA), using the 80/20 split.

The evaluation of the bids will be conducted in the following stages:

Firstly, the assessment of functionality must be done in terms of the evaluation criteria and minimum threshold value of **75 points**. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.

During phase two, only the qualifying bids are evaluated in terms of 80/20 preference points systems. 80 points will be used for price only and the remaining 20 points are for specific goal.

For functionality, the following criteria will be applicable and the maximum value of each criterion is indicated as below:

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

2. **The bid of any bidder may be rejected if the bidder, or any of its directors have:**
 - a) Abused the Municipality's Supply Chain Management System or committed any improper conduct in relation to such system;
 - b) Been convicted for fraud or corruption during the past five years;
 - c) Wilfully neglected, reneged or failed to comply with any government, municipal or public sector contract during the past five years; or
 - d) Been listed in the Register for Bid Defaulters in terms of section 29 of the Prevention and Combating of Corruption Activities Act (No 12 of 2004).

Certificate of Independent Bid Determination

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
