SPECIFICATION PA: FENCING

PA WORKS ON SITE:

PA 1 SCOPE

This Specification covers the moving of existing fences where necessary, the erection of new fences, the dismantling of existing fences and the stacking of the fencing material, and the replacing or repair of existing fences where so indicated on the drawings or as directed by the Engineer. Any deviation from this Specification will be included in the Project Specifications.

PA1.1 Where an existing fence is to be replaced it shall be removed entirely, including grubbing up of posts and stays complete with concrete blocks and filling of holes with good, clean approved soil and well compacted. All old fencing material to be removed from site.

PA1.2 On any site where it is found that the existing ground level on the fence line is higher than the adjacent finished walkway or street, the ground shall be excavated level with the finished walkway or street for a distance of one meter into the site and the two levels worked off to a neat and even finish for a further distance of one meter.

PA1.3 Care must be exercised not to damage private or the local authority's property on the outside of the fence line. Any claim for such damage shall be for the Contractor's account.

The Contractor must arrange with the owner of such property for mutually acceptable construction before commencement of the work.

PA 2 MATERIALS

PA 2.1 Posts

Posts, stays, standards and droppers shall comply with the requirements of CKS 82, SABS 280 or SABS 457 and shall be of the types and sizes as indicated on the drawings. Posts shall include gate posts, straining posts, corner posts and end posts.

Unless otherwise shown on the drawings, any of the sections specified in SABS 457 for posts, standards and droppers will be acceptable except that

wire droppers shall not be used. "Acceptable" shall mean "acceptable to the Engineer".

Lengths and sizes of posts, standards as well as spacing of holes shall be as shown on the drawings.

PA2.2 Bolts for stays

All exposed steel shall be hotdipped galvanised. Bolts shall be galvanised steel bolts of the required length and shall be at least 12 mm dia. All the necessary bolts, nails and washers shall be supplied with each post.

PA2.3 Wire

All wire shall be hotdipped galvanised (class C) with a first-class zinc coating and shall comply with the requirements of SABS 675.

- (a) Smooth wire shall be as for equivalent thickness of the wire specified below:
- (i) Fencing wire shall be high-tensile steel wire with a minimum diameter of 2,24 mm.
 - (ii) Straining wire shall be mild-steel wire with a minimum diameter of 4,00 mm
 - (iii) Tying wire shall be mild-steel wire with a minimum diameter of 2,50 mm for tying fencing wire to standards and droppers and 1,6 mm for tying netting and mesh wire to fencing wire.

PA2.4 Wire netting

Wire netting shall be fully galvanised mild-steel wire with a minimum diameter of 1,5 mm with 75 mm hexagonal mesh or as specified and shown on the drawings. The width shall be as shown on the drawings.

PA2.5 Diamond mesh

Diamond mesh (chain link fencing) shall comply with the requirements of SABS 1373.

The width shall be shown on the drawings and the edge finish shall be both sides clinched or barbed (diamond mesh details shown if necessary).

The finalising of what stage these progress payments will be determined before the signing of the contract. 10% retention will be deducted from each progress payment which will be held for a period of three months after date of final handover. There will be no allowance made for advance payments.
- The above contract will include penalties of 0.1% of the total contract value for every day over the completion date, which will be finalised before the signing of the contract. There will be allowance for certain delays such as inclement weather and public holidays.
- No variation orders for any extras will be considered without the prior approval in writing from the George Municipality.

NOTES**Site Works**

All building operations are to be confined within the property boundaries.

Contractor to ensure that the building site is properly secured with controlled access to and from the building site.

Contractor to check all documentation, working drawings, measurements and levels before any construction is commenced with, and to report any discrepancies.

Contractor to allow for the securing of the building site. Contractor is to supply and erect an adequate 1.8m high perimeter fence around the building site for both safety and security reasons – so as to prevent the access of any unauthorized persons on the site. Contractor will be responsible for the upkeep and maintenance of the above security fence during the project period.

Contractor will be held responsible for the provision of required safety and access signage to all accesses to building site.

Contractor to provide site office along with adequate lockable storage and toilet facilities for all staff. Contractor to liaise with municipality as to where to place site office, site toilets and building material and rubble so as not to interfere with the movement of traffic.

All building materials are to be stored on the building site and within the fenced area.

Contractor will be held liable for any damages to municipal property, directly or indirectly, as a result of the construction process, delivery of materials or as a result of damages caused by any labour or sub-contractors employed by the contractor.

Local Labour

Contractor to make use of labour intensive methods as far as possible.

Health & Safety

The appointed contractor must submit a health and safety plan from a registered Health & Safety Practitioner. The cost for the health and safety plan must be included in the quoted amount and will not be paid as a separate cost.

Workforce will have to wear personal protective clothing, i.e. overalls, safety boots, safety eyewear, hard hats, protective gloves and reflective vests.

Site area must be demarcated to restrict access for individuals or any animals from the surrounding area. If necessary, safety cones and construction signs will have to be placed on the fence / screen and in the road to make oncoming traffic aware of the construction taking place.
