1. SCOPE OF WORK

The Auctioneer is expected to provide the following services:

- 1.1 The appointed auctioneer will be responsible for conducting the on-line auction process from start (not limited to planning, advertising, auction services) to end (not limited to changing of ownership with the Licensing Department) on behalf of SASSA Head Office.
- 1.2 Ensure that the Auction comply with the Code of Conduct of the South African Institute of Auctioneers.
- 1.3 The appointed auctioneer must render and start with the auction services within five (5) working days after receiving an order.

2. SITE VISIT

- 2.1 The Auctioneer/s are invited to attend for site visit on the date and time specified on the advert.
- 2.2 The appointed Auctioneer is responsible for arranging a site visit on behalf of the interested buyers with SASSA for the purpose of car inspection as and when necessary. Date and time to be agreed between the appointed auctioneer and SASSA.

3. REPORTING

- 3.1 The appointed auctioneer is expected to have a meeting prior to the auction with SASSA to discuss the auction process.
- 3.2 Provide report and make available all information relating to the auction process/progress.
 - 3.2.1 SASSA is expecting the Auctioneer to report every 7 seven working days from the date of an auction advert.
- 3.3 Present a detailed auction report containing a reconciliation of all associated costs and proceeds after finalization of the auction process.

4. CONTRACT TERMS AND CONDITIONS

- 4.1 Proceeds of the auction must be paid to SASSA Head Office within seventy-two (72) hours after the auction process has been completed and SASSA will release the car/s only after the payment has been reflected and confirmed by SASSA.
- 4.2 Change of ownership will only start after the payment has been received and confirmed by SASSA.

5. BID CONDITION

- 5.1 SASSA reserves the right to negotiate with the preferred Auctioneer.
- 5.2 The Appointed Auctioneer may be subjected to positive security screening (vetting process).

6. EVALUATION CRITERIA

Proposals will be evaluated in accordance with the 80/20 preference point system, as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000). The evaluation shall be conducted as follows:

 - ✓ Phase 2: Administrative Compliance
- Stage 2:
 - ✓ Price and Specific Goals

a. STAGE 1 PHASE 1: SPECIAL CONDITIONS

- I. Auctioneers to be registered with the South African Institute of Auctioneers and the following to be submitted with the quotation:
 - o A **Valid and Certified Copy** of Membership with South African Institute of Auctioneers.
- II. Auctioneers need to have a reputable functioning on-line auction platform- please provide a commitment letter and specify the following as part of the returnable documents:
 - **website** that will be utilized for the auction
 - the **rights** to be able to utilise a website
 - **Letter to be signed** by the delegated authority

NB: SASSA will verify information provided by the Auctioneers and failure to comply with the Special Condition/s will result in the quotation being eliminated/ disqualified.

b. STAGE 1 PHASE 1: ADMINISTRATIVE COMPLIANCE

The bidder must submit the following:

- Fully completed and signed Standard bidding documents (SBD Forms)
- Certified Copies of ID Documents of Directors

NB: Failure to comply with the above requirements may result in your proposal being disqualified

Auctioneer/s (SASSA Salvage Value – total percentage quoted by the Auctioneers = bidding price).

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
