Specification for Digital homogenizer including compatible probes/blades

1. Should have a processing range of up 100 ml-
2. Speed should range from 5,000 rpm to 35,000 rpm
3. Power Rating of 125 watt max
4. The dimensions should be 9" H x 2.5" max diameter
5. Weight should be greater than 450g
6. Should have a warranty of at least 2 year
7. Motor stand should be included
8. Stainless steel probes of 10 MM in diameter Stainless steel probes
9. Hard tissue plastic generator tips
10. Demonstration on how to use
11. Delivery period to be included

12. Be able to provide after service

2. Compulsory requirements:

- 2.1. Valid current Tax Clearance Certificate and the pin code issued by the South African Revenue Services (SARS).

3. The above specified goods/services should be delivered / rendered to the ARC-Onderstepoort Veterinary Institute at above-mentioned delivery address.
4. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
5. Your written quotation must be deposited or emailed depending on the instructions given in the email.
6. All price quotations that have a rand value of R 30,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. The lowest acceptable price will score 80 points, the 20 BBBEE points will be allocated as follows:
