Nature of the Contract

This contract is a 3 years contract. The works will include the strip, quote and repairs on the Pumps, Mechanical Valves, Electrical Motors, Transformers, Electrical Panels, cabling, Piping and concrete works in our plants and substations on written order by the Municipality. This contract may be terminated due to poor performance based on service level agreement that will be signed by the Municipality and the appointed contractor.

The total project is in the administrative district of Dr JS Moroka Local Municipality. Tenderer are required to complete the schedule. The schedule will be evaluated and Municipality reserves the right to appoint one or more of tenders received.

Details of the contract shall be stipulated in the special contract between the Preferred Bidder and the Municipality (Service Level Agreement). Rates submitted shall be fixed for the first year of the project and shall be adjusted yearly thereof based on the CPI (Consumer Price Index) and inflation rate, and shall be subjected to be reviewed by the Municipality. Decision by the Municipality with regard to the Rate adjustment is final.

Test, Strip, Assess and Quote

The contractor will be notified to collect the pumps, electrical motors, control panel, submersible pumps and submersible mixers from Water purification plant, it substations and Waste treatment plant to the contractor's workshop where equipment will be tested, stripped, assessed. The contractor will strip the relevant equipment,

perform mechanical tests, visually inspection for faults and condition of each mechanical components.

The contractor must compile and submit an assessment report/quotation to the Divisional Manager: Electrical and Mechanical or Water Services who will have the final say in whether repair work must continue or not. The assessment report/quotation to the responsible manager must be submitted within the strip and assess period as indicated by the successful tenderer in the duration schedule of this project.

The assessment report/quotation shall detail the cause of the failure and the work required to bring the water pumps, submersible pumps and submersible mixers into proper and safety operation and shall include recommendation options regarding:

- Parts that require repair or replacement or
- Scraping of equipment

When the water pumps, submersible pumps, submersible mixers, electrical motors and electrical panels cannot be repaired/rewind after or when it is too costly compared to the new price; the equipment must be re-assembled, clearly marked with the workshop tag including the job number together with the assessment report and be delivered back to the Municipality. A separate rate is provided for the schedule.
