This phase consists of Mandatory and Non-Mandatory administrative compliance evaluation of all proposals. - 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS
