#### 1. Introduction

Siyathemba Local Municipality invites qualified service providers to submit proposals for conducting a forensic investigation into suspected cash theft within the municipality. The objective is to establish facts, quantify any losses, and recommend measures to strengthen internal controls.

#### 2. Background

The municipality has identified discrepancies in cash handling and financial records, raising concerns about potential misappropriation of funds. This investigation must be conducted in compliance with applicable laws and professional standards.
