### 1.1 DESCRIPTION OF SERVICE:. REPLACEMENT OF A COOLING SYSTEM FOR THE SAAPPA GLASSHOUSE, BIEN DONNE, CROP DEVELOPMENT

#### BACKGROUND:

The SAAPPA glasshouse at Bien Donne is currently housing different plant progenies (seedlings) from the Pear, Apricot, Plum and Peach breeding projects. The past 3 years seedlings from the grape breeding project was also grown in this glasshouse. The glasshouse needs to work at optimal temperatures. The current cooling system (Wetwall system) has come to the end of its maintainable lifetime.. This glasshouse is currently the only glasshouse that works optimal for plant growth and needs to be kept in such a state. If plants are lost due to the hot temperatures, it could cost the breeding projects thousands of rands and the lost off irreplaceable germplasm. The MDFX 9.6 Gutter Frame in stainless steel with integrated water reservoir is a modern but cost effective replacement and will not need old pumps and reservoirs to be fixed too.

#### PURPOSE

The current old glasshouse cooling system needs to be replaced by a new system. The glasshouse is shared by numerous breeding projects to raise their seedlings.
