TERMS OF REFERENCE FOR NEXT-GENERATION FIREWALL AND REPORTING ANALYZER**1. INTRODUCTION**

The South African Health Products Regulatory Authority (SAHPRA / The Authority) is the regulatory authority responsible for the regulation of health products intended for human and animal use, the conduct of clinical trials, as well as the licensing of manufacturers, wholesalers, and distributors of medicines and medical devices, radiation emitting devices, and radioactive nuclides.

The legislative mandates of SAHPRA are derived from the Medicines and Related Substances Act, 1965 (Act No. 101 of 1965), as amended (herein after referred to as “the Medicines Act”), and other relevant legislation, regulations, and policies.

In terms of the Medicines Act, the objectives of the Authority are to provide for the monitoring, evaluation, regulation, investigation, inspection, registration, and control of medicines, scheduled substances, clinical trials, medical devices, and radiation emitting devices, and related matters that are in the public’s interest.

SAHPRA transitioned into a public entity on 1 February 2018. Previously, the Authority was known as the Medicines Control Council (MCC), a sub-programme of the National Department of Health (NDOH).

SAHPRA charges fees for various services rendered in terms of its mandate. These fees are gazetted, and applicants pay fees prior to submission of application. Payment received are allocated in a clearing account (unallocated) until matched to an application where it’s added to the deferred income / income received in advance listing. Revenue is recognised on service rendered.

2. BACKGROUND

SAHPRA seeks to appoint a competent service provider registered on the national Central Supplier Database (CSD) for the Supply, Licensing, Deployment and Support of Two (2) Next Generation Firewall and Reporting Analyzer Appliance Solution for a period of thirty-six (36) months.

3. DURATION

The contract period shall be for a maximum of thirty-six (36) months.

4. SCOPE OF WORK AND SPECIFICATIONS

4.1. The service provider must supply two (2) enterprise-grade next-generation firewall and Analyzer appliances to replace the existing Fortinet 501E and FortiAnalyzer devices. The proposed solution must meet or exceed the performance, security, and operational capabilities of the current units.

Minimum required specifications:

- Hardware-based, rack-mountable enterprise next generation firewall appliances.

- Deployment of the Virtual Analyzer.
- Minimum 20 Gbps firewall throughput.
- Minimum 5 Gbps threat protection throughput.

- Advanced malware protection and anti-bot detection.
- Application control and web filtering capabilities.
- SSL/TLS deep packet inspection support (including TLS 1.3).
- Integrated SD-WAN functionality.
- IPsec and SSL VPN capability.
- Support for centralized management and reporting.
- Three (3) years of security subscription services including:
 - Threat intelligence updates
 - Malware and outbreak protection
 - Vulnerability protection
 - Web and application control databases
 - 24/7 Vendor technical assistance
 - Hardware replacement warranty – OEM Vendor

4.2. Security Analytics and Log Management Platform for reporting

The service provider must supply and configure a virtualized log management and security analytics system with the following capabilities:

4.2.1. Log Ingestion License

- Support for ingesting a minimum of 5 GB of logs per day.
- Minimum of 200 GB device quota.
- Storage and indexing of logs for analysis, compliance, and reporting.
- Full support for virtualization platforms (VMware, Hyper-V, KVM, or equivalent).

4.2.2. Threat Intelligence & Outbreak Detection (3 Years)

- Behaviour-based outbreak detection and automated IOC generation.
- Real-time threat and attack data from global intelligence feeds.
- Alerts, dashboards, and event correlation.
- Support for the 1–26 GB/day log ingestion tier.

4.2.3. Premium Support Subscription (3 Years)

- 24/7 vendor support for the analytics platform.
- Access to updates, patches, signatures, and enhancement releases.
- Remote troubleshooting and escalation options.

4.3. Managed Support Services (36 Months)

The service provider must provide comprehensive managed support services over a **36-month period**, including but not limited to:

- Monitoring and management of the firewall infrastructure.
- Migration of the current configurations to the new platform.
- Configuration and testing of High Availability (HA) in Active-Passive or Active-Active mode.

- Monitoring and management of the analytics/log management system.
- Continuous threat event correlation and incident triage.
- Monthly and quarterly reports covering security posture, incidents, and recommendations.
- Periodic firewall rule base reviews and policy optimization.
- Configuration backups, updates, and restoration services.
- Change management and technical advisory services.
- Vendor training and examination vouchers for two personnel.
- A minimum of 180 support hours per year or equivalent monthly allocation (bidder to specify allocation mechanism).

- i. The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.
- ii. The minimum technical threshold is **75 points**. Bidders that do not meet the minimum technical threshold will not be evaluated further for price and specific goals.

b. PRICE AND SPECIFIC GOALS POINTS

- i. All remaining bids will be evaluated as follows:
- ii. The 80/20 preference point system will be applied. Points for price and specific goals will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2022.
- iii. If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- iv. The point scored for the specific goals for each acceptable bid will now be added to the price point.
- v. The bid must be awarded to the supplier that obtained the highest preference points or may be awarded to a supplier that did not score the highest points only in accordance with section 2(1)(f) of the PPPFA.
