PROVISION OF ACCOUNTING TRAINING SERVICES TO SMME'S (CITY OF CAPE TOWN)

1. INTRODUCTION

The National Housing Finance Corporation (NHFC) was established by the National Department of Human Settlements as a development finance institution (DFI) in 1996, with the primandate of broadening access to affordable housing finance for the low- and middle-income households. NHFC is a national public entity, the NHFC adheres to the regulatory framework of the Public Finance Management Act (PFMA) of 1999.

The NHFC provides wholesale funding in the affordable housing market mainly to social housing institutions, non-banking retail intermediaries, privately owned property developers, construction companies and investors. It also provides loans and other form of wholesale funding (equity and quasi equity) to certain niche businesses that are in the affordable housing market.

2. BACKGROUND OF REQUEST FOR QUOTATION (RFQ)

The City of Cape Town has plans to repair and maintain the 57 519 rental stock units across the City of Cape Town and develop SMMEs contractors through an enterprise development programme. However, without any integrated development system including financing, incubation and support the programme is prone to failure through cessions and victimization of SMMEs. So CoCT in 2019 looked for a partner that will provide integrated and composite

enterprise development services in the City of Cape Town. NHFC presented its Enterprise Development services provided through the Programme Management portfolio.

At the heart of NHFC's enterprise development model is the need for incubation of the enterprises to learn both theoretical knowledge and practical skills. Incubation can best be defined as a transition process of sustained application of specifically required interventions, which will enable an element subjected to the process, to change from one state of being to another over a given period of time. In the context of small Contractor enterprise, the aim of the incubation is to gradually improve the developing contractor into an established contractor at the end of the incubation period.

The City of Cape Town is therefore entering into a service level agreement with NHFC with the sole intent to primarily repair and maintain the rental stock units and provide an integrated and responsive enterprise development programme for local enterprises on CIDB Grades GB 1-3 in the City. The NHFC has provided the City with a Programme Implementation Plan that will outline how the team will plan and execute the works as per the provisions of the service level agreement. The main thrust of the enterprise development programme is incubation. Critical to the development of SMMEs is the ability to supply them with financial and non-financial support. Critical to the implementation of the programme is to ensure that the small emerging contractors gain the necessary skills, one the skills identified is the basic financial skills for the SMME's.

3. PURPOSE OF REQUEST FOR QUOTATION (RFQ)

The purpose of this Request for Quotation (RFQ) is to solicit quotations from potential service providers for the provision of accounting and training services to SMME's.

4. SCOPE OF WORK

NHFC is looking to contract a service provider to meet the requirements for the provision of accounting and training services to SMME's in the City of Town. The specifications are as follows:

- Preparation of financial statements.
- Preparation of monthly management accounts to small emerging contractors.
- Provision of accounting services to 123 small emerging contractors.
- Provide basic accounting and business skills training to 123 SMMEs (training should be offered in groups of 4)

4.1 DURATION

The estimated period for this appointment has been scheduled for 6 months from the date of appointment.

5. EVALUATION CRITERIA

Price and Preference Evaluation

Evaluation of bids received will be conducted in three (3) phases as follows:

Phase 1 – Compulsory Requirements

Bidders will first be evaluated in terms of the gatekeeper/minimum requirements on page 1 of this document. Bidders who do not fulfil all the requirements or do not submit the required documents will not proceed to the next phase of functionality. Those who fulfil all the requirements or have submitted the required documents will be further evaluated on functionality.

Phase 2 – Functionality

Functionality is worth 100 points. The minimum threshold is 70 points. Bidders who score less than 70 points on functionality will therefore be disqualified. Those who score more than 70 points will be further evaluated in terms of price and preference points (i.e. on the B-BBEE status level of contributor). The functionality evaluation is broken down as follows:

Past Relevant Experience Bidders must have specific experience to carry out the scope of work required and submit at least three recent reference letters in respect of related service undertaken. Reference letters for previously completed work must be signed and contact details must be provided.	Total – 30 points

CERTIFICATE OF INDEPENDENT BID DETERMINATION

This Standard Bidding Document (SBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between

parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
