- f. **Firm Prices.** Are deemed to be the prices which are only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax which, in terms of a law or regulation is binding upon the contractor and demonstrably have an influence on the prices of any supplies, or the rendering costs of any services, for the execution of the contract.
- g. **Price Quotation.** Means a written offer sounding in money and reflected on the documentation wherein the offer was invited, duly completed and where necessary signed by or on behalf of the bidder.
- h. **GBC.** Means the General Bid Conditions.
- i. **Written or In Writing.** Means handwritten in ink or any form of electronic or mechanical writing.

- h. **Submission of Documents.** The bid documents are to be submitted with due consideration to the following:
 - i. The bid documents are not to be retyped or redrafted. Photocopies may be prepared and used, but the original signed document must be submitted with the bid.
 - ii. Bidders must check the number of pages and satisfy themselves that none are missing or duplicated.
 - iii. Bidders must bid in accordance with the requirements stipulated in the bid documents.
 - iv. Bids must be compiled in such a manner that it allows for easy cross-referencing between the bid document and the submitted bid.

- i. **Documents.** Bidders are to ensure that all required or specified documents are included in their bids.
 - j. **Compliance to Conditions and Specifications.** Bidders are to clearly indicate in their bids that their offers are compliant to the conditions and specification pertaining to the bid. If not, it must be clearly stated where and in which manner their offers are non-compliant to the conditions and specifications.
6. **Charge for Documents.** Where applicable and as required in the bidding documents or advertisement, a non-refundable fee for documents may be charged.
7. **Samples**
- a. The Department shall not make samples available to prospective bidders, unless specifically mentioned in the bid documents;
 - b. When samples are called for in bid documents, samples shall be delivered at the cost of the bidder to the addressee mentioned in the bid documents before the closing time of the bid. Bids shall not be included in parcels containing samples.
8. **Alternative Offers.** In the event that bidders offer products alternative to that called for, bids for such alternative offers shall be submitted on separate copies of the bid documents, but only if bids are submitted for the specified requirement.
9. **Partial Bids.** In the event that bids for supplies and/or sales are called for, bids may be submitted for less than the number of specified items, or part of the specified quantity or requirement called for in the bid.
10. **Bid Prices and Delivery Periods**
- a. **Firm Bids.** Firm bid prices and delivery periods are preferred. However, bidders may submit firm or non-firm prices and delivery periods. Where a bidder has not indicated whether his prices or delivery periods are firm or not, bid prices and delivery periods are deemed to be firm and the contractor shall be bound thereby. Expressions such as "soonest" or "earliest" or delivery periods which are unspecified are not acceptable.
 - b. **Contract Periods.** Where different prices are bid for different periods of the contract, the bid price applicable in respect of a particular period of the contract shall be a firm price if, as regards such period, it conforms to the definition of firm prices.
 - c. **Proof.** The Department may, where non-firm prices are offered, require that proof of costs of labour, material or other factors which are specified by the bidder, be submitted and, should the cost in the opinion of the Department not be realistic, same may be brought into consideration in the comparison adjudication of the bids.

11. **Validity Periods.** The period for which bids are to remain open for acceptance, valid and binding is indicated in the bidding documents and is calculated from the closing time and such offers are to remain open for acceptance, valid and binding until close of business on the last day of the period so calculated. Should this last day fall on a Saturday, Sunday or Public Holiday, the bid will remain open for acceptance, valid and binding until close of business on the first business day following such Saturday, Sunday or Public Holiday.

12. **Closing of Bids.** Bids close at the time and date indicated in the bid documents. Extension of the closing date may be granted if circumstances justify this action. The closing date is normally extended only if there is sufficient time to publish an amending notification before the original closing date.

13. **Lodging of Bids.** Concerning the lodging of bids the following shall apply:

- a. **Receipt.** Bids shall be lodged to ensure their actual receipt at the address before the closing time specified and in accordance with the directives in the bidding documents.
- b. **Envelope.** Each bid shall be addressed according to the directives in the bidding documents and shall be lodged in a separate sealed envelope with the name and address of the bidder, the bid number and the closing date indicated on the envelope. The envelope shall not contain documents relating to any bid other than that shown on the envelope.
- c. **Copies.** Unless specifically provided for in the bid invitation, no bids forwarded by e-mail, telegram, telex, facsimile or similar apparatus will be considered. Photostat copies of bids or photostat copies of faxes, signed in ink after being photostatted, will be accepted as valid bids.
- d. **Samples.** Bids shall not be included in packages containing samples as such bids may be rejected as being invalid.

14. **Open Bids or Unnumbered Envelopes.** All bids received in sealed envelopes with the relevant bid numbers on the envelopes are kept unopened in safe custody until the closing time of the bids. However, if a bid is received in an unsealed envelope or without an envelope, it shall be sealed in an envelope after the bid number has been written on the envelope.

15. **Opening of Bids.** Bids are opened in public as soon as practicable after the closing time and the names only of the bidders are read out, if so requested, at the time of opening the bids.

16. **Late Bids.** Bids are late if they are received at the address indicated in the bid documents after closing time. A late bid will not be opened or admitted for consideration and where practicable shall be returned unopened to the address appearing on the envelope.

17. **Consideration of Bids.** During the consideration of bids the following applies:

- a. **Bids Considered.** All bids correctly lodged are taken into consideration.

- b. **Position of Bidder.** The financial standing of bidders and/or their ability to manufacture or to supply goods or to render a service may be examined before their bids are considered for acceptance.
- c. **Comparative Prices.** In comparing bids, the prices are brought to a comparative level by deducting unconditional discounts, preferences and other benefits and adding delivery and other costs as applicable and bringing implied contract price adjustments into account. Non-firm bid prices are adjusted in accordance with the assessed contract price adjustments implicit in the non-firm prices. Where a range of delivery periods is quoted, the worst implied delivery period is used when calculating the comparative prices.
- d. **Preferential Point System.** Where bidding documents include documents relating to a preferential point system, the required calculations will be made and comparison of bids done on the basis of points earned through the preferential point system.
- e. **Adjustments to Prices.** The department reserves the right to rectify any incorrect calculations made by the bidder, but no adjustments may be made to the input figures.
- f. **Compliance to Specification.** Bids will be evaluated to establish compliance to product or service specifications, with due consideration to alternative offers and/or deviations to specification.
- g. **Evaluation Criteria.** Where bidding documents include evaluation criteria relating to functionality, for example bidder's capability, bidders profile, etc, the required calculations will be made and comparison of bids done on the basis of points earned.
- h. **Negotiations.** Unless otherwise stated in the bid documents, no negotiations will be entered into.
- i. **Communication with Bidders.** The Department may request clarification on information regarding any aspect included in the bid, which the bidder is to supply by the indicated date.
18. **Award of bids.** After prices have been brought to a comparative level and/or points calculated according to a preferential points system, the bid will be awarded considering the following order of priority:
- a. If the preferential point system is applicable, normally to the bidder with the highest points, unless reasonable and justifiable grounds exist for passing over the bidder with the highest points. In the event of equal bids, the award is according to the relevant regulation.
- b. If the preferential point system is not applicable, normally to the bidder with the lowest bid in the case of purchases by or services to the Department, or highest bid in respect of sales, unless reasonable and justifiable grounds exist for passing

over the bid with the lowest bid in the case of purchases by or services to the Department, or highest bid in respect of sales. In the event of equal bids, the award is according to the following order:

- i. Bidders offering firm bid prices as well as firm delivery periods.
 - ii. Supplies provided and services rendered from resources available within the Republic.
 - iii. Supplies and services from points nearest to the centres at which delivery is required.
 - iv. All things still being equal, the award shall be decided by the drawing of lots.
- c. The Department is not obliged to accept the lowest or any bid.
 - d. The Department may, where a bid relates to more than one item, accept such bid in respect of any specific item or items and also accept part of the specified quantity of any specific item or items.

19. **Quantities Other than Specified.** The Department may increase or decrease the quantities reflected in the bids, but will do so after consultation with the bidders that responded to the invitation to bid.

20. **Bidder's Incorrect Information.** Where a contract has been awarded on the strength of information furnished by the bidder, which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Department may, in addition to any other legal remedy it may have

- a. recover from the contractor all costs, losses or damages incurred or sustained by the Department as a result of the award of the contract; and/or
- b. cancel the contract and claim any damages which the Department may suffer as a result of having to make less favourable arrangements.

21. **Notification of Acceptance.** Successful bidders are notified by registered or certified mail of the acceptance of their bids, either through a contract form or by official departmental order forms.

22. **Furnishing of Bid Results**

- a. The following particulars of the successful bidders are normally published in the Government Tender Bulletin for general information:
 - i. Name.
 - ii. The price and delivery basis.

- b. Bids are not available for perusal by the public, but, at the written request of a bidder or interested party, the names and addresses of all bidders may be furnished over and above the information published in the Government Tender Bulletin.
- c. Requests for any further information will be treated as provided for by law.

23. **Amendment or Withdrawal of Bid.** If a bidder amends or withdraws his bid after the closing time and within the validity period or extended validity period, he shall reimburse the Department any damages if a less favourable bid is accepted or less favourable arrangements are to be made.

24. **Failure to Comply.** Where bidders fail to comply with any of these conditions, the Department reserves the right to invalidate bids received.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidised by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognised new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

- 1.11 "Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which has the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in

1.21 "Purchaser" means the organization purchasing the goods.

1.22 "Republic" means the Republic of South Africa.

1.23 "SCC" means the Special Conditions of Contract.

1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.

2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.

2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.

3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za or www.info.gov.za

4. Standards

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and

5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection

therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

(b) a cashier's or certified cheque

7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty

obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract amendments

18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

- 21.5 Except as provided under Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to Clause 22, unless an extension of time is agreed upon pursuant to Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

- 22.1 Subject to Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to Clause 23.

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to Clause 21.2;

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidised import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

25.1 Notwithstanding the provisions of Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause

thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

27.5 Notwithstanding any reference to mediation and/or court proceedings herein,

- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- (b) the purchaser shall pay the supplier any monies due the supplier.

31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

CO-ORDINATED ACTIVITIES

2. Whilst on Department of Defence premises, personnel of the contractor will have access to all areas, subject to other stipulations in the relevant contract, to render the services. If the contractor's service is not rendered in a specific area at a given time, access to that area is forbidden.

3. The work to be executed must under no circumstances disrupt the routine activities taking place in the institution or on the premises where the service is to be provided.

PROJECT SPECIFICATION

EXECUTION OF CONTRACT

INTRODUCTION

1. Supply, installation and commissioning of a sewer plant and associated services at Swartwater Military Operational Base in the Limpopo Province.

SCOPE OF WORK

2. General Description of the works

- a. The work shall entail the manufacture, supply transport and delivery and commissioning of a sewer plant and associated services as specified in the Project, Technical and Particular Specifications.
- b. The work shall include, but not be limited to the following:
 - i. Manufacture, Transport and deliver, commission and testing of sewer plant on site.
 - ii. Site clearance
 - iii. Plumbing and drainage related works.
 - iv. Construct a soak away French drain system
 - v. Dismantle and take down existing canopy and fencing and Erect new overhead canopy and fencing.
 - vi. Commission the plant.
 - vii. Provide onsite training (Skills Transfer) to Military Personnel during erection and commissioning stage as well as during monthly inspections.
 - viii. Maintenance for a period of three (3) years.

3. The contract period shall be for a period of no more than 12 weeks. Extension will only be granted if the delay is as result of an Act of God or due to Military Operational requirements.

DESCRIPTION OF SITE AND ACCESS ROUTES

SITE LOCATION

6. The site, on which the work will be performed, will be at Swartwater Military Operational Base, Limpopo Province.

- a. GPS Co-Ordinates: 22°50'47.61"S 28°12'34.90"E

- b. Access roads. Access to site can be gained by a gravel road servicing the area and into the base. The site is accessible by low bed transport vehicles.

COMPULSORY SITE VISIT

7. The site visit is compulsory for all tenderers to ensure that all site conditions are allowed for in their tenders.
8. All uncertainties regarding site conditions shall be cleared with the Engineer and recorded, in writing, in an Addendum issued by the Engineer's representative, before the closing date of this tender.
9. No claims in regard to uncertainties shall be entertained once the Contract has been awarded.
10. In addition to the compulsory site visit, the site may be made available for further detailed evaluations and inspections by the tenderers by prior arrangement.
11. Such arrangements must be made at the compulsory site visit, should it be required by any of the tenderers.

AUTHORITIES

12. Local SANDF Commander

- a. The Contractor and his employees shall at all times be subject to jurisdiction of the Local SANDF Commander.
- b. Any instruction issued by the Local SANDF Commander shall be communicated to the contractor on site, and if this requires reprogramming of the works, the contractor shall notify the Engineer within 48 hours of receipt of these instructions.
- c. If the Contractor is of the opinion that such instructions will lead to cost or time implications he shall submit a claim in accordance with the Conditions of Contract for approval.
- d. Such a claim will not be considered if the delay is less than 10 days and unless it is submitted in writing within 48 hours of its occurrence.

SITE ACCOMMODATION

13. Contractor's site camp

- a. The Contractor shall make his own arrangements regarding accommodation and transport for his employees. On site accommodation is not guaranteed and may not be available.
- b. The Contractor will not be allowed to make use of the ablution facilities of the Employer and should therefore make arrangements for own facilities.
- c. The cost to maintain these services shall be deemed to be incl. in the tender amount under the Preliminary and General section of the BOQ.

14. Contractor's offices, stores, workshops and repair facilities

- a. On completion of the Contract all temporary buildings, fences etc. which may have been erected on the site and at the contractors offices shall be removed and the sites left in a clean and tidy condition.
- b. The Contractor shall, for the use of his workmen, erect on or in the vicinity of the site operations, OHS approved ablution facilities and latrines which shall at all times be kept in a clean condition.

HEALTH SERVICES AND SAFETY REQUIREMENTS

HEALTH SERVICES

15. The Contractor shall provide and maintain suitable first-aid facilities for the full duration of the Contract. The first-aid facilities shall be approved by the Engineer.

The cost of these precautionary measures shall also be deemed to be included in the tendered price.

SAFETY REQUIREMENTS

16. It is a requirement of this contract that the Contractor shall provide a safe working environment and to direct all his activities in such a manner that his employees and any other persons who may be directly affected by his activities are not exposed to hazards to their health and safety.

17. To this end the Contractor shall conform to all the stipulations of the Occupational Health and Safety Act (Act 85 of 1993) and the Regulations applicable to the Machinery and Occupational Safety Act (Act No 6 of 1983), which *inter alia* provides for the designation of a health and safety representative (or representatives) where an employer has more than 20 employees in his employ.

COMMUNICATION ON SITE DURING THE CONTRACT PERIOD

18. The Contractor shall establish and maintain a reliable communication system on site to support his own activities.

QUALITY CONTROL OF MATERIALS AND EQUIPMENT

19. All materials and equipment used on this Contract shall comply with the requirements of this specification and shall be subject to approval of the Engineer and the Employer.

SECURITY ON SITE

20. The Contractor shall at his own cost, supply, install and maintain all buildings, fences, security barriers etc, that would be required for safekeeping of his equipment material, vehicles and tools as well as to ensure public safety during all stages of this Contract.

SITE SUPERVISION

21. All work shall be supervised by a full-time, suitably qualified and authorised representative.

22. The representative shall be authorised to act on behalf of his principles regarding all activities relating to this Contract.

23. He shall personally attend all meetings, which may be called by the Engineer or the Employer.

24. The Contractor shall employ as many employees as may be required, and shall also be compelled to remove and replace any employee against whom the Engineer or the Employer justly raises objections, either as a result of negligence, carelessness, incompetence, improper behaviour or unsatisfactory work performed by or under the supervision of such an employee.

25. The cost of replacing employees shall be borne by the Contractor. No claims in this regard will be entertained.

SAFEGUARDING OF OTHER SERVICES AND STRUCTURES

26. The Contractor shall be fully responsible for the safeguarding of all existing services and structures whilst performing his duties.

27. The cost of all precautionary measures, which may be necessary to ensure the safety of such services and existing works as well as the protection of all persons, animals and property shall be included in the tendered price.

28. The Contractor shall be held responsible for any damage, injuries or accident caused as a result of his failure to take necessary precautionary measures.

29. Any damage to any service or existing works by the contractor, shall be repaired forthwith at the Contractor's expense to the satisfaction of the Engineer.

30. The Contractor shall protect the working area during the execution of this Contract and shall indemnify the Employer in respect of all claims arising out of injury, or death of any persons entitled to be on the premises or the site, or claims arising out of damage to property.

INITIAL ACCEPTANCE OF THE WORKS BY THE CONTRACTOR

31. In terms of the General Conditions of Contract, the Contractor shall investigate and report to the Engineer within 14 days of the commencement date, any exceptional defects to the Works, which had occurred during the period between submission of tenders, and the commencement date of the Contract.

32. This report shall be accompanied by a detailed and itemised quotation of the costs to restore the Works to the same state as during the tender period.

33. The report shall include a detailed programme of all work to be carried out.

34. Normal wear and tear or deterioration shall not be considered as exceptional defects and shall not be reported on.

35. During the tender period the Contractor shall assess and evaluate his risks with regards to normal wear and tear or deterioration, and shall allow for the costs thereof in his tender price, as no claims for payment in this regard will be considered.

36. The Employer will not guarantee the state of the works to be in the same state on the commencement date of this Contract as it was at the tender stage.

37. No guarantees or undertakings are offered by the Employer in this regard.

MEASUREMENT AND PAYMENT

38. Any certificates or invoices submitted to the Engineer for payment shall be complete, fully detailed and shall include proof of actual cost where payment will be valued on a proven cost basis.

39. The contractor must confirm that his rates tendered are fixed.

40. **No escalation will be payable.**

41. Scheduled Items

- a. The Schedule of Quantities does not reflect all detail of items as specified but are for identification and pricing purposes only.
- b. The work covered by each item is described in the Technical Specification, Particular Specification and Plans.

42. Preliminary and general fixed-cost items

- a. Unit of Measurement: Sum.
- b. The tendered sum shall include full compensation for the Contractor's establishment on site including offices, workshops, storage facilities, housing for his own employees (whether on site or elsewhere) and all services.
- c. The sum shall also include the provision of telephone, telephone answering machine, facsimile, e-mail and site radio communication facilities needed for the complete service.
- d. Eighty percent (80 %) of the bid sum (for P&G only) will be made when the facilities have been provided and the contractor has established on site.
- e. The remaining 20 % will be paid when the works have been completed and the facilities have been removed and the site have been cleared and cleaned.

43. Separately listed items

- a. Various items as scheduled (by Tenderer) Unit of Measurement: Sum
- b. Should there be any items which the Contractor considers necessary to be scheduled in addition to those already listed, he shall enter and detail such items in the Schedule of Quantities.
- c. The tendered sum or rate or monthly rate shall cover all the costs for that item which the Contractor wishes to add.

MEASUREMENTS AND RATES

SCOPE

1. The existing waste water treatment plant was designed for approximately 50 PE by EDT (Euro Drain Technologies). This system must be repaired and upgraded to accommodate 200 PE with a soak away.
2. The Rotating Immersion Disk (RID) or Rotating Biological Contactor (RBC) Disk sewer plant shall be a modular plant. The system must be so designed as to be re-deployable.
3. The system shall be above ground as far as possible and the treatment processing shall be so designed to comply with all current standards and directives.
4. The Rotating Immersion Disk or Rotating Biological Contactor (RBC) Disk sewer plant shall be fully automated and the premise is a system which consists of three stages:
 - a. Mechanical Separation.
 - b. Biological purification.
 - c. Final Settlement
5. The system shall accommodate 200 personnel, and be a quite odour free operation.
6. The Technical specifications in this document serves as a guideline and may differ slightly between different suppliers and manufacturers.

STANDARD SPECIFICATIONS

7. The latest edition, including all amendments up to date of tender, of the following specifications, publications and codes of practice shall be read in conjunction with this specification and shall be deemed to form part thereof.
 - a. SANS SPECIFICATIONS AND CODES
 - b. NATIONAL ENVIRONMENTAL MANAGEMENT ACT (NEMA), No 107 of 1998
 - c. NATIONAL WATER ACT (NWA) No 36 of 1998
 - d. WATER SERVICES ACT No 108 of 1997
 - e. ENVIRONMENT CONSERVATION ACT (ECA), No 73 OF 1989
 - f. OCCUPATIONAL HEALTH AND SAFETY ACT No 85 of 1993

MANUFACTURERS' SPECIFICATIONS, CODES OF PRACTICE AND INSTALLATION INSTRUCTIONS

8. All equipment and materials shall be manufactured or assembled strictly in accordance with the manufacturers' specifications, instructions and codes of practice.

VARIATIONS AND ADDITIONS TO STANDARD SPECIFICATIONS

9. The following additional general specifications and requirements shall be read in conjunction with this specification and shall be adhered to unless otherwise specified.
 - a. General Requirements
 - i. All materials and equipment supplied and installed shall be new unless otherwise specified by the engineer, high quality and designed and manufactured to the relevant specifications and suitable for providing a reliable end product.
 - ii. All work shall be executed by qualified trained personnel.
 - iii. All equipment, component parts, fittings and materials supplied and/or installed, shall conform in respect of quality, to the requirements of the applicable current SANS specifications and codes, except where otherwise specified or approved by the Engineer in writing.
 - iv. All materials and workmanship which, in the opinion of the Engineer, are inferior to that specified for the work will be condemned. All condemned material and workmanship shall be replaced or rectified as directed and approved by the Engineer.
 - v. The Contractor shall submit a detailed list of the equipment and material to be used to the Engineer for approval before placing orders or commencing installation.
 - vi. The Contractor shall make sure that all safety regulations and measures are applied and enforced during the manufacturing to ensure the safety of the public and the User Client.

GENERAL TECHNICAL SPECIFICATIONS

10. The following general technical specifications are applicable. For specific detail, reference is made to the attached plans which must be read in conjunction with the Technical and Particular Specifications.

NEW RBC / RID SEWER PLANT

11. The complete plant shall consist of, but not limited to the following:
 - a. Grease Trap. To be installed at kitchen/mess.
 - b. Tank with Double pumping system. Grundfos type SEG.40.09.2.50B, one pump operating and other on standby, including flexible pipe and connection.
 - c. Double pumping system, brand Grundfos, type AP.35B.50.06.3, one pump working, one standby including flexible pipe and connection

- d. 3 Tank (Chamber 1,2 and 3)
- e. FD.(Flow Divider) Brand S&P or similar approved Type 2/1/1
- f. Cascade RIDs (Rotating Immersion Discs), type STK-E-2.000-1.068/2 with motor and supplement disc Ø2m, PP tanks 2/2 m discs (77/93), disc spacing 18-15 mm incl. roofing (detail elsewhere) for subsoil unit, GRP supports with Aluminium cover tank for subsoil unit, support structure.
- g. Scoop Wheel brand S&P or similar approved, diameter 2,0 m
- h. FD (Flow Divider) for reticulation S&P Type 1/2
- i. LMS (Lamella separator S7P or similar approved type LMS-7/1 incl. sludge removal pump Grundfos AP35.40.06.3.
- j. Flow Meter for Chlorine dosing system. brand ABB, type Processmaster FEP311 DN65 or similar approved.
- k. Chlorine Dosing System Reaction Tank Prominent or similar approved 60Liter black tank, beta pump, standard valve and suction set.
- l. Special switch and control panel, indoor version incl. 2 double pumping system, 1 motor, 1 sludge pump, flow meter and dosing pump Rittal control box incl. motor/pump protection, motor soft starter, hour meter, lights, plugs and material and equipment required to supply and commission
- m. All Installation parts (pipes, valves, package, documentation) installation material from double pumping system to outlet Lamella separator to ensure a fully operational system.

REPAIR UPGRADE AND CONNECT OLD EXISTING PLANT

- 12. Design supply installation and commissioning on site is deemed to be included in the cost in the schedule of quantities. The following general technical specifications are applicable. For specific detail, reference is made to the attached plans which must be read in conjunction with the Technical and Particular Specifications. The bidder must inspect the existing plant to determine any other material, fittings or components required to commission and connect the unit.
 - a. Basic Control Panel, indoor installation incl. motor and sludge pump. Rittal or similar approved control box incl. motor pump protection, motor soft starter, hour meter lights and plugs and related equipment.
 - b. All Installation parts (pipes, valves, package, documentation) installation material from double pumping system to outlet Lamella separator to ensure a fully operational system.
 - c. Installation parts, incl. all pipes, fittings, valves from chamber pit to LMS.
 - d. Four Gas Struts for roof.
 - e. Installation parts pipes, valves and fittings to ensure proper installation and commissioning.

SOAKAWAY SYSTEM

13. The contractor shall construct a soak away system as per Drawing No 002 at position as indicated on site by the Engr.
 - a. All labour , plant and material required to construct the soakaway is deemed to be included in the cost in the Schedule of Quantities.
 - b. Effluent into the soakaway system shall comply to the Dept of Water Affairs regulations and standards and shall be monitored as part of the monthly maintenance contract (elsewhere described).

EXTERNAL WORKS

14. Site Clearance
 - a. Clear site of all vegetation to ensure a level surface.
 - b. The extent of site clearing shall be the actual area of the position of the unit plus 5 meter strip around the unit and soakaway system.
15. Removal of existing overhead canopy
 - a. Remove existing steel canopy and set aside on site as indicated by the engineer.
 - b. Care should be taken not to damage the recovered material.
16. Supply and erect new overhead canopy
 - a. Supply and erect overhead roof canopy, manufactured from steel lipped channel sections for the roof members and 75mm x 2mm square tubing posts in concrete footings.
 - b. The roof covering shall be galvanized 0.5 Full Hard IBR roof sheeting unpainted, fixed to lipped channel purlins.
 - c. The canopy shall be so constructed as to cover the entire plant and extend the plant by 2 meters meters on all sides.
 - d. All metal (except galvanised roof) shall be painted with two coats etch primer and two coats enamel paint (colour white).
17. Remove existing Chain link fence
 - a. Remove existing chain link fence (approx. 34m) incl. poles and set aside.
 - b. Post shall be either completely removed or cut 300mm below ground level.
18. Supply and erect palisade fence and gate
 - a. Palisade panel size shall be 3000mm wide x 1800mm high with 30mm x 30mm pales, hot rolled and spaced with 100mm gap between pales (20 pales per panel).

- b. Two horizontal angles size 40mm x 40mm x 2mm as cross members.
- c. Spike type shall be devils fork plus four.
- d. All panels shall be welded to 2400mm high x76mm x76mm x1.6mm square tube posts with cap and base plate. Poles to be planted at a depth of 400mm.
- e. Pre-manufactured Sliding Gate to be 6000mm wide constructed of a 100mm x 50mm x 1.6mm frame and with 30mm x 30mm x 1.6mm angle iron uprights. The gate shall be fitted with two 80mm wheels and guide rollers. The gate track shall be fixed in concrete.
- f. All metal work (palisades and gates shall be painted with two coats red oxide etch primer and two coats water based roof paint colour: Heritage Green.
- g. The fence should extend 5 meters on all sides of the plant to allow access and work space for future maintenance. The contractor to determine the length based on the footprint of the specific sewer plant to be supplied.

19. Concrete Slabs

- a. All tanks and units shall be placed on 15Mpa concrete slabs, minimum 100mm thick, reinforced with mesh reinforcing Ref 145.
- b. All slabs shall extend beyond the limit of the tanks and units by 1 meter on all sides. Edges of all slabs shall be finished off neatly with a nosing tool and slabs shall be steel floated.

SEWER DRAINAGE

20. Grease trap

- a. Supply and install grease trap commercial type separator as supplied by Grease Traps South Africa Type GTS 7l/S or similar approved, at mess and make good.
- b. Separator to be manufactured from 304/316 A Grade stainless steel 1.2mm thick with Plastic lid and removable collection Basket or similar approved by engineer.
- c. Flow rate of 7 litres be suitable to accommodate the effluent of the mess at peak capacity of 200 personnel.

WATER RETICULATION

21. Freshwater Tap

- a. Supply and connect 20mm Rough Brass tap next to sewer plant as indicated by the engineer.
- b. Water supply from nearest connection shall be 25mm HDPE Class 12 water pipe connected to a properly secured ¾" galvanized standpipe. The approximate distance is 50m to connection point but the bidder to verify during site meeting.
- c. The freshwater supply shall further also include a 20 mm x 30 meter Garden Hose, heavy duty with Gardena or similar approved hose fittings on both ends of hose as well as tap connector to suit and adjustable spray nozzle.

ELECTRICITY

22. Electrical Lighting

- a. Supply and connect 2 LED 5Ft T8 double tube open light fittings, incl T8 LED Tubes, fittings, conduit, switches circuit breakers and wiring.
- b. All wiring shall be in approved conduit.
- c. Switch shall be weatherproof outdoor switch Masterplug single switch or similar with an IP 55 rating.
- d. Supply and fit 16 Amp Daynight sensor Mataltec or similar approved.

MAINTENANCE

23. Maintenance to the system shall include but not limited to the following.

- a. The contractor shall maintain the sewer plant and components, tanks pumps and all parts in order to comply with the effluent parameters as specified in the Part 2 Particular Specification.
- b. Check service and maintenance of all electrical components, moving parts, grease bearings, service struts, gearbox and discs.
- c. Collect sample of effluent and conduct tests by an approved and authorised laboratory and submit results to the Engineer on a monthly basis. Any deviation outside the parameters as per Part 2 Particular specification must be rectified with immediate effect within 24 Hours. A second test must be done after rectification which will be for the account of the contractor.
- d. The contractor shall keep a register of all maintenance and services as well as all test conducted with results and submit to the Engineer for approval in order to effect maintenance payments.
- e. Any failure of the plant which results in the deviation of the effluent parameters or results in spillage of sewage is considered an emergency repair and must be rectified within 48 hours.

GUARANTEE OF INSTALLATION, EQUIPMENT AND WORKMANSHIP

24. The Contractor shall provide and obtain guarantees warranties from the manufacturer(s) and/or supplier(s) of equipment and fittings to the effect that each piece of new equipment, supplied and installed in the system, shall comply with the required performance and will function as part of the complete system.
25. The equipment including the shaft shall be covered under guarantee commencing on the date of issue of a Certificate of Completion for the works.as follows:
 - a. Rotating Immersion Discs (including shaft): 3 years
 - b. Lamella Separator: 3 Years

- c. Pumps, motors, bearings and electrical control cabinets:1 Year
- d. Equipment and components by third parties the warranties by the respective manufacturers should be completely transferred to the customer (Dept of Defence).
- e. The contractor must guarantee against defects in design, material and workmanship.

TESTS AND INSPECTIONS PRIOR TO PRACTICAL COMPLETION

- 26. All systems are to be re-checked by the contractor prior to commissioning. Copies of all checks for each installation shall be presented to the Engineer for approval before commissioning takes place.
- 27. It is the responsibility of the Contractor to provide all labour, accessories and properly calibrated and certified measuring instruments necessary to supply a certificate of compliance for each unit.
- 28. The contractor must give 1 (one) weeks' notice to the Engineer prior to testing.

TESTS AND INSPECTIONS ON COMPLETION OF REPAIR WORK

- 29. On completion of repair work the Contractor shall prior to commissioning test the unit and equipment.
- 30. Except where otherwise provided in the Contract, the Contractor shall provide labour, materials, power, fuel, accessories and properly calibrated and certified instruments necessary for carrying out such tests. Arrangements for these tests shall be made by the Contractor and he shall give at least 72 hours written notice to the Engineer before commencing the test.
- 31. In the event of the plant or installation not passing the test, the Employer shall be at liberty to deduct from the Contract amount all reasonable expenses incurred by the Employer or the Engineer attending the repeated test.
- 32. Whenever any installation or equipment is to be operated for testing or adjusting as provided for above, the Contractor shall operate the entire system for as long a period as may be required to prove satisfactory performance at all times in the occupies space served by that system for up to twenty-four hours a day continuously until the certificate of practical completion of repair work is handed over.
- 33. The Contractor shall provide all labour and supervision required for such operation and the DoD may assign staff as observers, but such observation time shall not be counted as instruction time.
- 34. After complete installation of the system all equipment shall be tested, adjusted and re-adjusted until it operates to the satisfaction and approval of the Engineer.
- 35. The Contractor shall submit certificates of tests carried out to prove the performance of all equipment, as well as certificates obtained from all the relevant authorities and statutory bodies, etc.
- 36. The Contractor shall only utilise Departmental approved inspection authorities for all inspections and tests to be conducted. This will be done and approved in writing among the relevant parties.

MEASUREMENT AND PAYMENT

GENERAL INCLUSION OF COSTS IN THE TENDERED RATES

37. The cost of manufacturing, supply, transport to the site, placing, erection, levelling and commissioning of all equipment and components is deemed to be included in the tendered rate.
38. The tendered rate shall further include full compensation for the provision of all equipment, plant labour and fittings required to erect and test and flush the unit in terms of this specification. This includes all interfaces, subsoil connections, electrical connections fittings and components.
39. Any site clearing and sludge removal is deemed to be included under site clearance in the Schedule of Quantities.

CONDITION OF ASSESSMENT

40. The characteristics and the quantity quality of the waste water is deemed to be in accordance with the assumed figures and it is on the premise that the wastewater does not contain toxic or inhibiting substances, which are shown in the design calculation Part 2 Particular Specification (Table 01).
41. Standard sanitary conditions of inlet wastewater are assumed unless otherwise specified.

General design layout of new unit

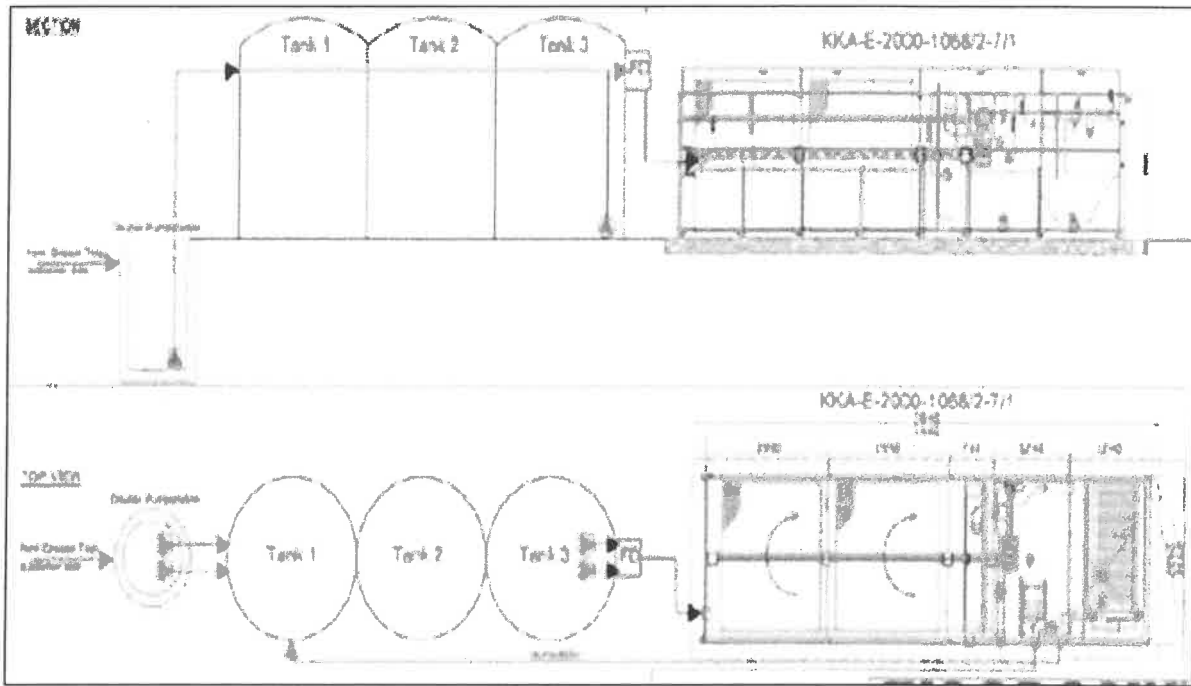
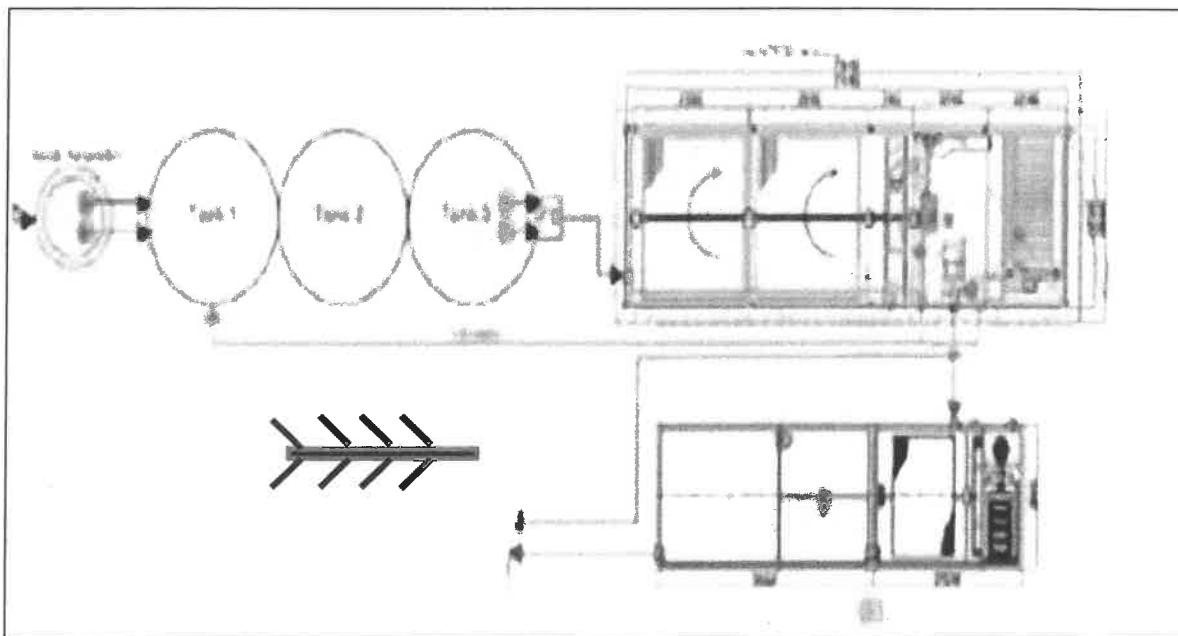
