Notice is hereby given that a compulsory clarification meeting will be held on **Wednesday, 19 July 2023** at the Skills Centre, corner of Van Schalk Wyk Street and Mandlenskosi Street situated in Beaufort West at **11:00**. Documents will only be available for collection at the compulsory clarification meeting if tenderers booked their bid document in advance before **Monday, 17 July 2023 at 14:00**. No tenderers will be allowed to attend the compulsory clarification meeting if they arrive more than 15 minutes after the meeting commenced.

A non-refundable fee of R250.00 (Two hundred and Fifty Rand), is payable for a set of printed documents. Sealed Bids, marked "**BID SCM: 03/2024: INSTALLATION OF CONNECTION SERVICES AT SKILL CENTRE, BEAUFORT WEST**" must be addressed to the Acting Municipal Manager and placed in the tender box at the Office of the Supply Chain Management Unit in the Sanlam Building, 112 Donkin Street, Beaufort West, before the closing time and date of **14:00 on FRIDAY, 04 August 2023**. Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in black ink by hand and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid.

Bids must be submitted on the original documents and must be valid for a period of 120 days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, Preferential Procurement Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2022. Points will be allocated for the following specific goals: (a) contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability; and (b) promotion of enterprises located in the municipal area (WC053).

It is a prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database; register without delay by completing the prescribed form. Application forms are obtainable on Central Supplier Database website at www.csd.gov.za.
