anyone can respond. Respondents in this process will receive no preference in any subsequent open tender process, apart from their information supplied being utilized in the preparation of the Foskor scope/specification.

2 DEFINITIONS AND INTERPRETATION

In this RFI, except as otherwise defined herein, the following terms shall have the following meanings:

- 2.1 Coal Fired Dyers Foskor owns and operates six (6) Coal Fired Dryers for drying Rock Phosphate. These dryers are rotary kilns, fired by Coal with average capacity of drying about 80-100 tons of Rock Phosphate per hour. Three dryers use Stocker mechanism to fire the coal whereas the remaining three use Fluidised bed system. The details are as follows:
 - Product Dried: Rock Phosphate
 - Dryer Operating Temperature: 750-900 degrees Celsius
 - Average throughput of Each dryer: 80-100 tons per hour of rock phosphate
 - Product Inlet moisture: 8-10%
 - Product outlet moisture: 1-1.5%
 - Average Coal consumption of Each dryer: 0.6tons per hour
 - Typical Specification of the Coal Used: Grade B Peas Coal with Calorific Value range 26.5 to 27.5 MJ/Kg
 - Location: Foskor Mine, Phalaborwa, Limpopo
- 2.2 **Alternative Fuels** refers to the targeted alternative fuels such as Natural Gas (in either Liquid or Gas phase), Biodiesel, Biomass, Waste Oil (Vegetable or Motor Oil) Methanol, Hydrogen/Ammonia (in either Liquid or Gas phase) to be used as fuel in the existing Coal Fired Dryers, after retrofitting them for the alternative fuel;
- 2.3 **Respondent** any entity or consortium that submits a RFI Response in response to this RFI;
- 2.4 **RFI Request for Information** inclusive of technically substantiating documentation validating, in this case the:

3 BACKGROUND

Foskor holds a pre-eminent position in the global agricultural landscape as one of the world's largest producers of highquality phosphate rock (concentrate) and phosphoric acid. Our unique standing as one of the few vertically integrated producers of phosphoric acid underscores our robust capabilities

and control over the value chain. As the leading domestic producer and supplier of phosphate-based products, including phosphate rock, phosphoric acid, and Mono-Ammonium Phosphate (MAP), Foskor is a cornerst

ne of agricultural productivity in South Africa and across the SADC regional markets (such as DRC, eSwatini, Zimbabwe, and Zambia).

Our reach extends significantly beyond regional borders. We strategically supply phosphoric acid to vital international markets including Bangladesh, the United Arab Emirates, Europe, and India. While the primary application for our high-quality phosphate rock concentrate is within our own phosphoric acid manufacturing plant in Richards Bay, we also strategically export available products to a diverse range of international markets, including Europe, Asia, and South America.

Our integrated operations begin with the ownership and mining of phosphate resources at Phalaborwa, located in the Limpopo Province of South Africa. Here, we beneficiate the mined material to produce a high-grade phosphate concentrate. This concentrate is then either sold locally or efficiently transported to our Richards Bay plant on the coast of KwaZulu-Natal. At Richards Bay, we further process the concentrate to produce phosphoric acid, sulfuric acid, and granular fertilizers such as MAP. It is at this Richards Bay facility that we react the phosphate concentrate with sulfuric acid, which is manufactured in-house from imported sulfur, to produce phosphoric acid. A significant portion of our phosphoric acid is exported to markets such as Bangladesh, India and Europe, with approximately half of this volume further beneficiated into granular fertilizer that primarily serves the crucial local South African market. Foskor's deep commitment to sustainable growth and operational excellence, as guided by our Journey to 2028 strategy, that ensures our continued role as a vital contributor to global food security.

The information being sought should include, but is not limited to:

- a) **Phase 1**: A pre-feasibility cost comparison of coal combustion energy source versus alternate more environmentally friendly combustion sources such as, but not limited to Natural Gases, Biodiesel, Biomass, Waste Oil (Vegetable or Motor Oil) Methanol, Hydrogen/Ammonia (in either Liquid or Gas phase) for use as fuel in the existing Coal Fired Dryers after retrofitting them for the alternate fuel.
- b) **Phase 2**: (Future RFI) Based on the cost comparison outcome of the pre-feasibility assessment (Phase1) the subsequent Phase 2 may contemplate the request for the following information which would require a detailed assessment of the current infrastructure and equipment. - b) Obtain information to better define the scope, cost/budgeting and extent for the envisaged Request for Proposal for the retrofit as informed by the outcome of this RFI should Foskor decide to proceed with the RFP.
