### 3 SPECIFICATIONS:

#### Introduction

Onderstepoort Biological Products SOC Ltd (OBP) is a state-owned company distributing animal health products against mostly livestock diseases with severe economic impact and can impact negatively on the country's food security. OBP manufactures more than 50 animal vaccines and other diagnostic reagents. As a state-owned entity OBP currently distributes its products to distribution points such as Agricultural coops, wholesalers, veterinarians, feedlots, and provincial department of agriculture. The purpose is for farmers, i.e., beef, dairy, sheep/goat farmers and horse owners, and more importantly small and emerging farmers to access its products.

#### Objective/Purpose

The purpose of this procurement is to acquire a reliable, efficient, and high-performance centrifuge that meets the operational needs of Bacterial Vaccines Department. This document serves as a guideline for all stakeholders involved, detailing the essential specifications, procurement procedures, evaluation criteria, and responsibilities to ensure a transparent, competitive, and compliant purchasing process
