ANNEXURE A: SCOPE OF WORK

1. **PURPOSE** OF THE REQUEST FOR QUOTATIONS

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitable e-waste service provider to provide disposal of IT electronic equipment on a once-off basis.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

2. EXTENT OF WORK

2.1 THE SCOPE OF WORK

The Service Provider will be responsible for:

- The appointed e-waste service provider must provide certainty that all computers will be disposed of in a safe manner and that equipment will be destroyed to ensure no retrieving of data is possible.
- The appointed e-waste service provider will be expected to sign a confidentiality clause indicating that no intellectual property found or discovered on the e-waste assets may be used for any purpose, distributed for any purpose, or communicated to any persons/organizations whatsoever.
- The ATNS shall retain ownership to and remain vested with all rights, title, and interest in and to any Intellectual Property, including without limitation to know-hows, trade secrets and/or materials which have been created or developed by the ATNS SOC Ltd.
- The appointed service provider will indemnify and hold the ATNS harmless against all claims of any nature whatsoever, arising out of the willful or negligent acts or omissions of the service provider, or any person acting for and on behalf of the service provider and the service provider must carry sufficient insurance to cover any such claims.

- The e-waste service provider must undertake to provide the ATNS with the services of e-waste disposal in terms of the legislative e-waste disposal requirements and methods.
- The e-waste service provider will need to collect e-waste from Bruma (Johannesburg Eastgate).
- The e-waste service provider will provide their own manpower to load and off load any e-waste collected from the ATNS.
- The e-waste service provider should own or have access to suitable vehicles to collect bulk e-waste assets in Bruma (Johannesburg -Eastgate).
- All e-waste assets collected by the service provider will be assessed in terms of its refurbishment possibility or destruction.
- If the asset cannot be refurbished, it shall be destroyed, and all resultant products separated and disposed of in terms of the e-waste legislation. Any revenue collection will belong to the service provider.
- If an asset can be refurbished, all intellectual property will be removed and destroyed, all computer programs that require licensing on the equipment must be removed.
- The service provider must comply with any Occupational Health and Safety Acts, Environmental Waste Management Acts, Hazardous Substances Acts and any other relevant legislative requirements.
- The service provider will be responsible for ensuring that the processes undertaken by the service provider are free of fraud and corruption. This will include the reporting of individuals, whether they are ATNS staff or members of the public who approach the service provider with any offer that is considered fraud or corruption.
- Any e-waste assets collected will be stored at the service provider's premises and at their own cost.
- The e-waste service provider must supply ATNS with a cost to dispose of the assets; or provide an offer to purchase and collect the assets from the ATNS.
- The e-waste service provider must provide a Disposal Certificate to ATNS detailing all the e-Waste items disposed of.

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "**the Act**" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).


