**THE FOLLOWING CONDITIONS WILL APPLY:**

- Price(s) must be valid for at least ninety (90) days from the closing date.
- Price(s) must be firm and must be inclusive of VAT.
- Tenders will be evaluated in terms of the Municipality's Supply Chain Management Policy as well as the Preferential Procurement Policy and Preferential Procurement Policy Framework Act.
- This tender will be evaluated in terms of the 80/20 preference point system.
- A certified/original B-BBEE certificate and a municipal account in the name of the bidder must be submitted with the tender.
- Points will also be awarded for locality: Proof of locality means: a municipal account in the name of the bidder not older than three months, a lease agreement where the bidder is the lessee, or an official letter from the bank confirming the registered business address of the bidder.
- The lowest or only tenders will not necessarily be accepted.
- A valid tax status pin must be submitted.
- Potential service providers who were found guilty of fraud or corruption or who willfully neglected reneged on or failed to comply with any government, municipal or other public sector contract during the past five years, will be excluded from this process.
- A copy of the latest Municipal account on the address of the business. NB: bidders may not be in arrears for more than three months (90 days) with municipal rates and service charges)/if a business has entered into a lease agreement for the use of a building, the lease agreement should accompany the tender.
- Only service providers who are registered on the Central Supplier Database (CSD) will be considerate. Proof of registration should be attached to the tender documents.

**NB: No tenders will be considered from persons in the service of the state.**

Failure to comply with these conditions may invalidate your offer.
