1. PURPOSE

To appoint a Strategist to conduct a series of workshops with various management groups to assist SANParks to co-create a roadmap with the aim of becoming a People centric; SMART (Technologically Advanced) and Sustainable (Green, Blue and Brown energy) organisation.

2. BACKGROUND

The South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

3. SCOPE OF WORK

SANParks seeks to contract a Strategist, to through a series of workshops, with various level and groups of management to assist them to co-create a roadmap towards it becoming a People Centric; SMART (technologically advanced) and Sustainable (green, blue, and brown energy) organisation. The project milestones include the facilitation of six (6) consultative workshops (a hybrid of in person and virtual) with a wide range of management staff that would lead towards a gap analysis, and a roadmap inclusive of a practical implementation plan.

The initial key outputs will be:

- (1) The facilitation of six (6) workshops with key management staff from the D and E levels on the Patterson Scale to:
 - Create a “leader-shift” through the creation of a platform for strategic conversations amongst management by partnering for performance
 - Establish a cohort of leadership to re-engineer their approach to work, wellness, and engagement to deliver impact and sustainability.
 - Break the current thinking patterns

- Harness the collective and individual talents to leave it better than it was found in.
- Make sense of complex challenges to drive human performance
- Assist the team to step up as thinkers, doers and changemakers
- Bring possibilities to life.
- Lead from the front, from the trenches, and from the heart

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
