GENERAL CONDITIONS OF THE BID PROPOSAL

2.1 Definitions

In these Conditions of Bid, words and expressions shall have the meanings assigned to them in the various parts of the Bid Documents and in addition, the following words and expressions shall have the meanings assigned to them hereunder:

Words and Expressions	Meaning
"Addendum" and "Addendum to Bid"	any document so entitled and pertaining to the Bid, as may be issued by the Council to prospective Bidders at any time prior to the Closing of Bids
"Authorised"	by or with the prior written instruction, consent or approval of the Council and "unauthorised" means the converse.
"Closing of Bids"	the time and date before which Bids must be received by the Council and after which no further Bids will be accepted by the Council.
"Conforming Bid"	a bid which is strictly in accordance with the Bid Documents in all respects, without variation, addition, omission or qualification whatever.
"Bidder"	any person, firm, or juristic party which submits a Bid to the Council in response to the Invitation issued or published by the Council inviting the submission of Bids.
"Bid Period"	the period between the issue by the Council, of an invitation to submit Bids for the project or the issue of the Bid Documents, whichever is the earlier, and the Closing of Bids.

2.2 INTERPRETATION

2.2.1 APPLICATION

These Conditions of Bid govern the submission and adjudication of proposals and the acceptance by the Council of any proposal. They shall not form part of nor be interpreted or construed as forming part of any subsequent Contract as may result from the acceptance by the Council of any Bid received, nor shall these Conditions of Bid have any force or significance in any such subsequent Contract.

2.2.2 LANGUAGE

2.11 ADDITIONAL INFORMATION REQUIRED

2.11.1 The Council may request any Bidder to clarify any aspect of its Bid and also reserves the right to instruct a public accountant to report on the financial status of the Bidder, and the Bidder must render all reasonable assistance in such an investigation.

2.11.2 The additional information so obtained, as well as all written information submitted by the Bidder with and in support of its Bid, will be considered to form the basis on which the Bid has been prepared and submitted.

2.12 TAXES AND LEVIES

The testing services should be provided continuously on a monthly basis without fail to the customers. The water testing of the Local Municipalities is linked to the Blue Drop and Green Drop certification program of each local municipality.

A service provider or service providers is required by the Laboratory for referral and sub-contracting services to conduct various analyses on water and sludge samples. The Laboratory to offer the service should be accredited.

The referral service is offered on a monthly basis continuously for testing determinands which the GSDM laboratory does not yet have in-house competence to conduct, and the sub-contracting service will be offered as and when required due to the GSDM Water Quality Laboratory temporarily not being able to perform the testing in-house. The current services contract will expire in November 2025.

The list of referral and sub-contracting determinands to be tested is established by the Laboratory. The referral list is provided and determinands which are considered complementary for awarding are clustered a suite to be awarded as one.

The sub-contracting list comprise of determinands currently tested by the GSDM Water Quality Laboratory. Some determinands are accredited and others not yet accredited. The Laboratory that offers the sub-contracting service should be accredited for the method that the GSDM Water Quality Laboratory is accredited.

Water Quality Laboratory on Potable Water, Raw Water, Wastewater and Sludge samples as and when required, for a period of three years.

Referral service is required when the Laboratory does not yet have competence to perform specific activities with the intention to acquire competence in future or continue to refer based on cost-benefit analysis.

Sub-contracting service is required when the Laboratory has the competence to perform specific activities, however due to unforeseen circumstances it is temporarily unable to undertake these in part or in full.

The Gert Sibande District Municipality seeks to appoint suitable and competent (SANAS Accredited) service provider(s) to provide the referral and the sub-contracting testing services to the Gert Sibande Water Quality Laboratory.

The laboratory has a list of determinands for referral, sub-contracting services for testing on the water samples and test list for sludge samples. The list of these determinands will be reviewed on an annual basis depending on methods that the GSDM Water laboratory has included or removed in the scope of in-house testing. As the GSDM Water Laboratory implements methods in-house, these methods shall be removed from the referral list of determinands, and these shall be added to the sub-contracting list of determinands for the Laboratory.

The list of referral and sub-contracting determinands to be tested is established by the Laboratory. The referral list is provided and determinands which are considered complementary for awarding are clustered as a suite to be awarded as one.

For the determinands on the referral list, the bidding Laboratory should be able to conduct the listed determinand(s), that is, it must have in-House competence to conduct the method / testing, and the Laboratory's Limit of Detection (LOD) for the method should be lower than the indicated Standard Limit.

The list of sub-contracting determinands comprises of twenty two (22) determinands which are tested in-house, some accredited and others not accredited. The bidding Laboratory must be accredited for the methods that the GSDM Laboratory is accredited, and the Laboratory's Limit of Detection (LOD) for the method should be lower than the indicated Standard Limit. 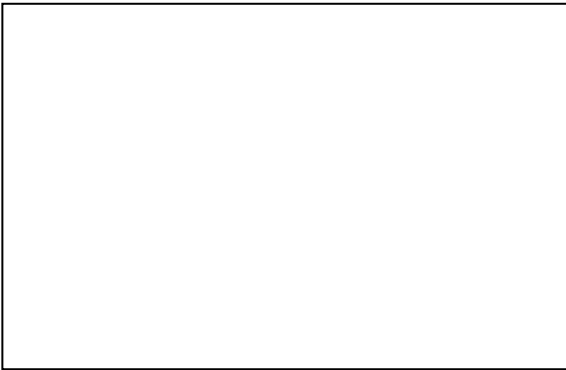
