 - 2.2. Only bidders that claim specific goals will be considered for scoring on the 20 points as per the 80/20 principle.
 - 2.3. Completed and signed Standard Bidding Documents (SBD) forms included in the bid document.
3. The above specified goods/services should be delivered / rendered to the ARC-Onderstepoort Veterinary Institute at above-mentioned delivery address.
4. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
5. Your written quotation must be emailed depending on the instructions given in the email or advert.
6. All price quotations that have a rand value of R 2,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2022 and its Regulations.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean

that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

Quotations must be supplied with detailed technical brochures and/or information sheets. Deviation from specifications must be mentioned and fully explained.

1	System must be based on two separate units, one for providing type 1 water and one for type 2 water (see below).		
2	Both units supplied fully functional with all relevant filters and treatment packs/columns installed. (NB! – Quotation must include these columns/packs and filters)		
3	Both units should be covered by a factory warranty 12 months or more from date of commissioning.		
4	Electrical connections: Supply voltage 230 VAC single phase (must be able to cope with fluctuations of at least 10% from 230V).		
5	Must be supplied with a surge protection plug		
6	Supply frequency 50Hz		
7	Service provider must have at least one factory trained service technician for water systems and must include training documentation with the quotation.		
8	Service provider must have fully equipped workshop and client may visit the workshop to verify that it actually exists.

2	Quotation must include an original equipment storage tank of not less than 100L, manufactured from opaque high grade polyethylene or similar material that will not affect the quality of type 2 water. Tank must come factory fitted with ports that have taps for connection to the type 1 and 2 purification units, a dispensing port with tap for type 2 water, an overflow port, a tank level indicator and a vent filter of 65µm or smaller.		
3	Must have one on-board pretreatment pack or cartridge for removal of particles, colloids and free chlorine from the feed water.		
4	Resistivity of type 2 water not less than 5MΩ/cm at 25°C and a TOC smaller than 30ppb.		
5	Bacterial count in the water must be 10cfu/mL or less.		
6	Bacterial count of stored water must be controlled by exposure to a 254nm UV lamp before entering the storage tank.		
7	Type 2 water must be produced by a 3 step process that starts with a pretreatment cartridge followed reverse osmosis (RO) and finally passing through an electro-deionization (EDI) module.		
8	Must be supplied with a wall-mounted pre-filtration unit with an installed and pre-filtration cartridge.		
9	Tap feed pressure: compatible with at least 0.5 to 5.8 bar Must have alarms and display for at least the following system parameters: a) Low pressure

10	Must have a screen showing important user information linked to maintenance, running conditions and user input for responding to alarms and alerts.

4	Must be supplied with a 0.22µm point of delivery filter that can provide water with a bacterial count of not more than 0.01 cfu/mL.		
5	Variety of POD filters must be available that can cover at least removal of bacteria, nucleases, proteases and pyrogens.
