3. Scope of work for Accommodation and transportation

3.1 Executive Overview

Accommodation around Witbank or Middelburg

3.1.1 The Supplier is to provide Bed, Breakfast Lunch pack and Dinner (starch, vegetables and protein) and transportation of Learners to and from on weekly basis including week ends. The supplier shall furnish all facilities, furniture, equipment and supplies, management supervision, and labour to provide lodging accommodations, as specified herein. Such services shall be provided in accordance with applicable laws and the conditions set forth in this Scope of Work.

3.2 QUALITY CONTROL:

The Supplier shall establish and maintain a complete quality control program for the performance requirements of this contract

3.3 LIABILITY:

The Government assumes no liability for damage caused by the occupants. The Supplier shall be responsible for resolving any damage claims caused by an occupant; and the Contractor shall be responsible for notifying the Service Manager of any claims against an occupant and the nature of the incident not later than 24 hours after the departure day.

3.4 ROOMS:

- 3.4.1 The sleeping facilities furnished shall be solely based on one individual to a bed. Pull out beds and sofas shall not be used in substitution for an actual bed.
- 3.4.2 Personnel shall be assigned rooms that are the same quality that are assigned to regular guests.
- 3.4.3 Rooms shall be constructed and furnished to provide good light and sound reduction.
- 3.4.4 All windows shall be provided with blackout lining, shades, or blinds. If drapes are provided, they must screen out the light.
- 3.4.5 Sufficient electrical outlets shall be available and in good working condition.
- 3.4.6 All entrance doors to rooms shall have interior security locks, either deadbolt or double locking locks and each room occupant shall be provided with a room key.
- 3.4.7 The rooms must have lockable storage space for personal belongings.
- 3.4.8 Rooms shall have adequate heating and cooling capabilities.
- 3.4.9 Furnishing and Equipment: Must be clean and in good repair. The following minimum furnishings are required:
- a. Lamp 1 per desk or writing table
- b. Adequate clothes storage drawers and closet space
- c. Desk or writing table with chair

3.5 BATHROOMS:

- 3.5.1 Bathrooms must be constructed to provide convenient sanitary facilities. Bathrooms must contain a shower and/or tub combination with a washing basin (with hot and cold water), a properly functioning toilet, and a mirror. Additionally, bathrooms should have adequate lighting and grounded electrical outlets for use of electrical razors, hair dryers etc.
- 3.5.2 The shower or shower/tub combination shall have shower doors or curtains.

3.6 SAFETY, SECURITY AND EMERGENCY PLANNING

The contractor shall provide the following at the premises:

- Conduct a Hazard Identification and Risk Assessment (HIRA) for the premises and activities performed.
- Provide first aid boxes in compliance with the Occupational Health and Safety Act and ensure they are adequately stocked.
- Ensure that personnel are trained in basic first aid and that at least one trained first aider is always present.
- Display Nearby Police station numbers, Nearby Hospital numbers, Nearby Fire Brigade numbers, and Emergency evacuation plan and provide training to all relevant personnel who will always be on the premises
- Implement regular health and safety inspections to ensure compliance with applicable standards and regulations.
- Maintain incident and accident reporting procedures.

3.7 SANITATION SERVICE

Daily custodial services shall include, but is not limited to, room cleaning, bed making, linen change (as required), bath towels, hand towels, sanitized drinking glasses, facial tissues, and a bathmat.

3.8 LINEN SERVICE

Linen service shall be provided once a week or when occupancy changes, whichever occurs first. Additional blankets shall be made available if requested by occupant. All linen and blankets shall be clean, freshly laundered, without any objectionable odours, and in good condition, free from tears, rips, holes, stains, and extensive wear

3.9 ADDITIONAL DESIRABLE AMENITIES

3.9.1 COMMON USE AREAS:

The supplier shall keep all hallways, corridors, grounds, and other areas under the contractor's control in a clean, neat, and safe condition

4.1 KITCHEN

- Contingency plans must be in place for breakdowns or delays.
- The vehicle must have operating permit to transport passengers and to use the particular route.(eg. Shuttle services).
- The vehicle must be insured with passenger liability insurance.
