REQUEST FOR QUOTATION FOR GRAP 104 IMPLEMENTATION

1.1 BACKGROUND

Johannesburg Water (JW) was incorporated on 21 November 2000 and commenced business on 1 January 2001. The entity is wholly owned by the City of Johannesburg.

The primary objective of this appointment is to engage a service provider to review Johannesburg Water's financial statements, ensuring they remain accurate, up-to-date, and compliant with relevant accounting standards on an as and when basis. The service provider will also provide accounting support during the audit process, offer technical opinions on audit findings, and advise on the application of the GRAP standards.

This service is crucial for ensuring compliance with regulatory requirements and maintaining the integrity of Johannesburg Water's financial reporting. Without this service, Johannesburg Water risks non-compliance with accounting standards and the potential for an adverse audit opinion, which could have significant operational, financial, and reputational consequences. Securing this service proactively manages these risks, preserves the integrity of Johannesburg Water's financial processes, and supports a successful audit outcome.

1.2 Scope of work/Terms of reference

In accordance with accounting standards, the annual financial statements will be prepared by Johannesburg water and the service provider will be provide AFS reviews as and when required by the entity, this will include opinion on the implementation and application of certain aspects of the GRAP accounting standards.

Johannesburg Water intends to appoint a service provider to deliver accounting technical services, including the review of financial statements, on an as-and-when-required basis.

- Conduct technical reviews of the Annual Financial Statements to ensure compliance with relevant accounting standards.
- Assist with the interpretation, application, and implementation of the GRAP Reporting Framework and taxation services, providing expert opinions and advice as needed.
- Provide on-site or telephonic technical accounting advice on internal controls and audit matters.
- Offer technical guidance and support on the application of new or amended accounting standards as they emerge.

1.3 Requirements

a) The service provider is required to meet the following criteria:

Capability to provide all services required at a single blended rate per hour. (Multiple rate offerings will result in disqualification.)

- Company's experience in technical accounting support which includes relevant work on at least 4 projects within public entities in the past 5 years.
- Submission of professional accountant's CVs reflecting a min of 7 -8 years of experience with in-depth knowledge and practical experience in the Municipal Finance Management Act

(MFMA), Generally Recognized Accounting Practice (GRAP) standards, auditing and extensive expertise in reviewing financial statements.

- Submission of South African Institute of Chartered Accountants Registration

These requirements ensure that the consultant is well-equipped to handle the complexities of accounting standards and AFS reviews, maintaining the highest level of accuracy and compliance.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
