1.2 **To be completed by the organ of state**

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

## **SPECIFICATION FOR THE SUPPLY OF CODE TWO BACKUP FOR OFFICE 365, ACTIVE DIRECTORY MANAGE ENGINE AND PLURALSIGHT SUBSCRIPTION LICENSES FOR THREE (3) YEARS.**

### **1. BACKGROUND**

The SADPMR is in Kempton Park, Corner Bonaero Drive and Cote D Azur Avenue (HeadOffice). The SADPMR is running on Microsoft 365 and has on-premises Active Directory servers.

### **2. OBJECTIVE**

The main objective of this project is to ensure that all SADPMR Microsoft 365 user account mailboxes, SharePoint data, OneDrive and Teams data are backed up. Active Directory Manage Engine will be required to manage both on-premises and Azure accounts. Pluralsight.com licenses will be required to access the online learning portal.

### **3. REQUIREMENTS**

The SADPMR requires the following services:

- 3.1 Code-two backup for Office 365 – 130 licenses
- 3.2 Manage Engine for Active Directory Management Professional – 1 domain license.
- 3.3 Access to PluralSight.com subscription – 3 user licenses
- 3.4 All license subscriptions must be valid for 3 years.
