## 1. INTRODUCTION

#### 1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on mine health and safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

Noise-Induced Hearing Loss (NIHL) remains a serious occupational health concern in the mining industry. Both surface and underground mining operations rely on a variety of heavy machinery to extract minerals. This equipment includes large fans to supply oxygen to workers and remove toxic gases and heat, drilling machines used for mineral extraction, and earth-moving equipment for loading and hauling. While essential, these machines generate high levels of ambient noise, which significantly contribute to hearing loss among mine workers. According to the National Institute for Occupational Safety and Health (2024), one in four mine workers have a hearing problem, and four in five mine workers have hearing impairment by their mid-60s. The South African mining industry's

long-term vision is achieving Zero Harm, making NIHL elimination a critical priority. Notably, in the SAMI, between 40% to 80% of workers involved in drilling operations experience hearing loss after 10 years of exposure. Additionally, in 2016/2017, the mining industry reported a 30% prevalence rate of occupational noise-induced hearing loss.

During the 2014 MHS Summit, a milestone was set to eliminate NIHL through the quietening of equipment. The milestone required all equipment utilized in the SAMI to emit total operational or process noise not exceeding a milestone sound pressure level of 107 dB(A). The milestone for the sound pressure level of total operational or process noise emitted by individual pieces of equipment and individual process equipment in the SAMI was reviewed down to 104 dB(A) during the 2024 MHS summit and this milestone must be achieved by December 2034.

Achieving the milestone on the quietening of equipment requires collaboration between mining companies, original equipment manufacturers (OEMs), research institutions, and government bodies. These stakeholders must work together to develop and implement suitable engineering noise control methodologies that maintain noise levels of existing equipment below the set targets and ensure that newly developed equipment is quieter than current machinery.

To achieve the milestone of reducing equipment noise, the Minerals Council South Africa initiated the Industry-wide Buy and Maintain Quiet Initiative (IBMQI):

This initiative is a collective decision made by mining companies to procure new equipment and machinery, as well as maintain existing machinery, in compliance with relevant noise emission standards. The IBMQI highlights that participating in an industry-wide initiative is significantly more cost-effective for mining companies in South Africa than pursuing individual reactive engineering solutions and measures.

The primary focus of the initiative is on measuring and managing noise sources to control noise hazards during the design phase of equipment and machinery. It involves engaging with manufacturers and suppliers to prioritize noise reduction in their product development. Additionally, the IBMQI promotes industry best practices for the procurement of equipment. The process also

includes a comprehensive literature review of past research on noise reduction in the mining industry, specifically examining modifications or enhancements to equipment and machinery that have successfully reduced noise emissions. This shift in focus aims to manage and control noise at its source.

The proposed research should build on the outcomes of the IBMQI Research Consolidation Report and Critical Noise Equipment Screening results in the form of the design and development of the most appropriate Engineering Noise Control Methodologies for application to the various Critical Noise Equipment screened, enabling the SAMI to achieve the 2034 Equipment Noise Emission Milestone of 104dB(A). The proposed evidence-based Engineering Noise Controls Methodologies developed should be based on the silencing principles, applicable to the equipment type, power source, etc. (e.g. control of pneumatic air release, impact noise, etc.) within an operational work environment.

## 2. PART A: THE CONTRACT

#### 2.1 CONTEXT OF THIS PROCUREMENT

The MHSC seeks to appoint a service provider to undertake research on the development of engineering noise control principles for application to mining equipment.

#### 2.2 CONTRACT PERIOD

The duration of this project is expected to be **18** Months.

**Note:** The **15** months will be allocated towards the project work.

The **3** months will be allocated to MHSC administrative duties, such as project initiation, contracts, and project closeout.

#### 2.3 DETAILED SPECIFICATIONS/SCOPE OF WORK

To achieve the requirement of the research, the service provider must:

- 2.3.1. Conduct a review of local and international literature on effective engineering noise control methodologies for equipment/machinery used in the mining industry and other heavy-duty industries.
- 2.3.2. Evaluate and analyse the Minerals Council South Africa's Screening Tool (1) results, considering the ten factors that influence the noise exposure risk of employees to noisy equipment. The critical factors for each of the mining equipment listed in the IBMQI report must be evaluated and linked with appropriate established control measures as determined in 2.3.1.
- 2.3.3. Develop a list of potential practical and implementable engineering control measures for application to the types of mining equipment listed in the IBMQI Research Consolidation Report utilizing the outcomes from **2.3.2.**
- 2.3.4. Conduct a workshop in Gauteng (hosted by the service provider) with relevant stakeholders to present the preliminary findings and solicit inputs on the developed engineering noise control principles for application on mining equipment.
- 2.3.5. Conduct on-site evaluations at an operating mine of the identified engineering noise controls as determined in 2.3.3. of the top eight (8) critical pieces of equipment (stratified; but not duplicated; across all power source categories of mining equipment, or the commodities listed) as per the outcome of the Screening Tool Analyses for the following commodities: 2 controls for Gold, 2 controls for Coal, 2 controls for Platinum, and 2 controls for Other Commodities (as a minimum).

**NB**: Noise measurements to be conducted in accordance with established and recognized noise measurement methodologies.

2.3.6. Analyse the findings from **2.3.5.** and provide recommendations for improvements on identified noise control measures.

2.3.7. Conduct another workshop in Gauteng (hosted by the service provider) with relevant industry stakeholders, inclusive of technical experts/specialists, OEMs, etc. to present the findings and solicit inputs.

- 2.4.4 A report on the workshops conducted as required in **2.3.4.**
- 2.4.5 A report on the on-site evaluations as outlined in **2.3.5**.
- 2.4.6 A report on the analysed findings as outlined in **2.3.6.**
- 2.4.7 A report on the second workshop as outlined in **2.3.7**.
- 2.4.8 A draft report inclusive of all project findings.
- 2.4.9 A final report.

A digital version on USB containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope. These serve as the original sets of bid documents and form part of the contract.

#### 4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.

- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.
- 4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

#### 4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

#### 4.4 MANDATORY COMPLIANCE - CENTRAL SUPPLIER DATABASE

### 5. PART D: BID EVALUATION PROCESS

The evaluation process will be conducted in various stages. To move to the next stage of evaluation, the previous stage of evaluation must have been fully complied with.

#### **5.1 REQUIRED EXPERIENCE**

The service provider must have at least **5** years' experience in conducting applied research and the project team must have members with expertise in the following areas:

- 5.1.1. A minimum of **10** years' experience in Mechanical Engineering with exposure to noise controls engineering.
- 5.1.2. A minimum of **10** years' experience in Occupational Hygiene / Mine Environmental Control Engineering in the Mining Industry.

NB: Bidders should note that the above is not an evaluation criterion, however bidders should take note of the requirements to be able to render the services. The evaluation criteria is stipulated in the next section below.

### 5.2.3 PRICE AND PREFERENCE (SPECIFIC GOALS) EVALUATION PHASE 2

- Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:
  - (i) **Price** with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury's General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
