The purchaser must assure the site be left clean at completion of their collection and removal of the goods.

The scope of work will include the purchase, Collect and Remove 20MVA Transformer at Rigi Substation Serial No. 451272. Buyers must show their interest to participate by submitting all tender returnable specified on the tender enquiry.
