uMngeni-Uthukela Water operations concern the supply of bulk water and the disposal of bulk waste water. It is a State Owned Entity listed in Schedule 3B of the Public Finance Management Act, 1999 (PFMA) (Act No. 1 of 1999). The Nsezi water purification plant has a capacity to treat 260 ML/d. The plant has two raw water sources which are Mhlathuze River and Nsezi Lake. The raw water turbidity ranges from 10NTU up to more than 4000 NTU. The plant is consist of the following process units: coagulation, flocculation, sedimentation, re-coagulation, re-flocculation, dissolved air flotation, filtration and disinfection. Chemicals are required to ensure constant supply of treated water to the contracted customers
