1. INTRODUCTION AND PURPOSE

Tshwane Bus Services (TBS) is continually improving customer service and upgrade the operational reliability and consistency of services by tracking of the events at the premises where CCTV are installed and monitoring the activity of workers and buses. Therefore, it is very important to maintain and repair the Closed-Circuit Television (CCTV) System installed in TBS premises.

2. BACKGROUND

Proper CCTV maintenance of your system is vital to the effectiveness and operation of the system as a whole. Dust and dirt accumulate on the cameras, even though they are in housings, the lenses will become dirty which affects your picture quality, and your recording system probably also requires some attention. Like any other piece of equipment that is in use daily your CCTV system requires maintenance to keep it up to peak performance.

CCTV will also require repairs from time to time. The cameras have a lifespan but something like a lightning surge can cause enough damage that it requires a replacement camera.

The cables might get damaged during a cleaning process, construction or even mice or rats gnawing through the cabling. This can be fixed and should be done sooner rather than later and at the same time add additional measures to prevent the damage from happening again.

- Routine Maintenance – Recommended frequency: Annual.

Fault Attendance Service

You must provide a fault attendance service on twenty-four (24) hours per day, seven (7) days per week basis for all CCTV faults.

Typical causes of CCTV faults include:

- Control gear malfunctions,
- CCTV failures,
- Overheating,
- Moisture or dust ingress,
- Accident damage,
- Storm damage, and
- Vandalism

4. DELIVERABLES

This document sets out requirements for the Maintenance of Closed-Circuit Television Systems (CCTV) Systems. CCTV includes the CCTV asset and all supporting components of the system and site. The requirements herein are for Services relevant to a CCTV site, so that they remain in good condition, operate as designed and meet the specified performance requirements.

The successful service provider will be responsible for the provision of preventative, planned and reactive maintenance service on a quarterly basis. The bidder will be required to respond to system faults on unlimited call outs.

The successful bidder will also be responsible for supply and installation of new equipment and parts on an ad hoc basis subject to approval.

All product items replaced should carry a minimum guarantee or warrantee of at least one year.

STAGE 3: PREFERENCE POINTS SYSTEM

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
