1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 To be completed by the organ of state

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

BACKGROUND TO IZIKO MUSEUMS OF SOUTH AFRICA

Iziko Museums of South Africa (Iziko Museums) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 12 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

1. OVERVIEW

Iziko invites suitably qualified accredited companies to submit a bid for the supply and installation of an air compressor, its piping and distribution board at the Iziko South African Museum.

2. PROJECT BRIEF

Iziko South African Museum currently has two compressors. The existing Air Compressor system included:

Compressors:

2 x CECCATO CSA15/8 G2 compressors (2019)

Receiver:

1 x Ingersoll Rand 504m³ receiver (1985)

Aftercooler:

1 x Hiross aftercooler (1984)

Air Dryer:

1 x Quincy air dryer qp21 9 (2019).

These are in the process of repair, but we need a new air compressor to be installed in close proximity. Any brand can be considered with specifications listed in the scope below. Final selection should be based on a site assessment, including duty cycle, compatibility with existing compressors, air demand peaks, existing piping, noise limits, and service support.

Ultimately, the three compressors will need to work together so that if one fails, others will engage. Any additional equipment required for the new installation and ensuring tandem interaction of the compressors, piping, or work required on the electrical distribution board is to be included in the quote. All electrical certifications are to be presented on completion of work.

3. SCOPE OF WORK

This specification defines the requirements for a new compressed air system to support simultaneous use of pneumatic tools and equipment in the palaeontological fossil preparation and conservation laboratory environment at Iziko South African Museum. The system must deliver clean, dry, oil-free air at appropriate flow and pressure levels for precision work while ensuring minimal noise and vibration within the laboratory setting.

3.1 Operational Requirements

The system shall be capable of supplying compressed air to multiple simultaneous workstations, including air scribes, micro-abrasive tools, pneumatic hand tools, and microscopes requiring compressed air assistance.

Minimum delivered flow: 1 700–2 800 l/min (60–100 CFM) at operational pressure.

The system shall provide stable and adjustable air pressure in the range of 7–10 bar (100–145 psi) to accommodate a range of tools and ensure consistent performance at each workstation. To run the full range of air scribes simultaneously we need to ensure that the oil free, dry, air coming out of the outlets at the benches in the laboratory has an air pressure of 8.5 bars. Because of the distance from the compressor, there will be some pressure loss. We have pressure gauges on each outlet to do minor adjustments.

3.2 Air Quality and Cleanliness

Given the laboratory and conservation environment:

- Compressed air shall be oil-free and certified to ISO Class 0 to prevent contamination of sensitive fossils and equipment.
- The system shall include filtration and drying to achieve a pressure dew point $\leq +3^{\circ}\text{C}$, ensuring air is dry and free of liquid water, oil, and particulate contaminants.

3.3. System Components

- Oil-free rotary screw compressor with Variable Speed Drive (VSD) for energy efficiency and pressure stability. Alternatively, a high-capacity oil-free scroll compressor may be proposed if it meets flow, pressure, and noise requirements.
- Equipment required to ensure successful installation and longevity of new compressor, as well as equipment required to have all compressors working in tandem.
- An integrated refrigerated or desiccant dryer sized appropriately for the compressor and expected duty cycle to maintain the required dew point.
- Multi-stage filtration including:
 - Pre-filtration (≥ 1 micron)
 - Fine particulate filtration (≤ 0.01 micron)
- An appropriately sized air receiver tank to stabilise system pressure, reduce cycling, and support peak demands during simultaneous use.

3.4 Noise and Vibration Control

The system shall be specified and installed to ensure:

- Maximum sound level \leq 60–65 dB in adjacent laboratory spaces to avoid disruption to preparators and researchers.
- Low vibration mounting to prevent transmission of vibration into adjacent workbenches and sensitive equipment.

3.5 Installation, Controls, and Monitoring

- Compressor, dryer, and filters installed in a dedicated mechanical space with adequate ventilation.
- Compressed air distribution piping shall minimise pressure drop and be suitable for laboratory use (e.g., corrosion-resistant materials).
- Digital controller with operational displays showing pressure, temperature, dew point, and maintenance alerts.
- All electrical work on the DB board.
- All piping required to install the unit and ensure functionality of all three compressors together.

3.6 Commissioning and Testing

The contractor shall:

- Test and verify air quality to confirm ISO Class 0 compliance.
- Demonstrate stable pressure delivery at all designated workstations under simultaneous load.
- Confirm dew point and filtration performance.
- Provide written commissioning reports and test certificates.

3.7 Documentation and Training

The contractor shall provide:

- Operation and maintenance manuals
- As-installed drawings and control schematics
- Recommended routine service schedule
- On-site training for facilities and laboratory staff covering safe operation, basic servicing, and fault identification
- 6 call outs to respond to basic servicing and troubleshooting needs.

3.8 Warranty and Support

- Minimum 24-month warranty on supplied equipment.

4. TECHNICAL KNOWLEDGE AND INFRASTRUCTURE

Contractors with suitable technical knowledge of air compressors, piping, controls, instrumentation, and electrical control DB's. Service providers must have a CIDB Grade 2 ME or higher. Please provide certification with compliance documents.

5. PRICING SCHEDULE

Pricing Instructions

1. Payment will be made based on the deliverables for the goods received.
2. Payment will only be made on the basis of work completed satisfactorily, and invoices provided and approved by the project manager.
3. Offer to be valid for 60 days from the bid closing date.
4. Iziko Museums does not make full upfront payments. Payment will be made in agreed tranches linked to delivery milestones, with a maximum 40% deposit. Final payment will be made upon satisfactory delivery.
