DETAILED SPECIFICATION

REQUEST FOR A SERVICE PROVIDER TO SUPPLY, LICENSE, INSTALL, AND CONFIGURATION OF A FORTINET FORTIGATE-80F APPLIANCE TO REPLACE THE EXISTING FORTIGATE-80E FOR TRADE & INVESTMENT KWAZULU-NATAL.

1. BACKGROUND

1.1. Trade & Investment KwaZulu-Natal is a South African trade and inward investment promotion agency, established as a Schedule 3C public entity, to promote the province of KwaZulu-Natal as an investment destination and to facilitate trade by assisting local companies to access international markets. In terms of the Public Finance Management Act, Act No.1 of 1999, as amended (PFMA), Trade & Investment KwaZulu-Natal must fully comply with all the requirements of the PFMA and all other relevant and applicable legislation.

1.2. Trade & Investment KwaZulu-Natal is governed by the KwaZulu-Natal Trade and Investment Agency Act, 2010 (Act No. 05 of 2010). In terms of chapter 2 section 4 (1) and (2) of the KwaZulu-Natal Trade and Investment Act, the main functions of the entity are to:

- Identify, develop, market, and promote investment opportunities in the province to international and domestic investors.
- Develop the export capacity of the province.
- Develop the export market of the province.
- Foster trade and investment within the province.
- Develop a provincial investment and export plan for the development, promotion and marketing of inward investments and exports from the province; and
- Keep and maintain a database of investment opportunities within the province in such a manner as to benefit all sectors of the economy.

2. PURPOSE

The purpose of this Request for Quotation (RFQ) is to solicit competitive bids from qualified and authorized Fortinet suppliers for the procurement, installation, and configuration of a FortiGate-80F Next-Generation Firewall, including FortiCare Premium Support and FortiGuard Enterprise Protection for a period of twelve (12) months.

This upgrade is required to replace the current FortiGate-80E firewall, which will reach end-of-support in August 2026, and to ensure continuous network security, improved performance, advanced cyber threat protection, and compliance with TIKZN's ICT security standards.

2. MOTIVATION

Trade and Investment KwaZulu-Natal (TIKZN) currently operate a FortiGate-80E firewall that will reach end-of-support in August 2026. To maintain a secure, reliable, and compliant network security infrastructure, there is an urgent need to upgrade to the latest supported model.

The FortiGate-80F offers enhanced performance, improved security capabilities, and advanced threat protection required to defend against evolving cyber threats. This upgrade will strengthen perimeter security, support increased user and application demand, ensure business continuity, and align with TIKZN's cybersecurity standards and organisational ICT

strategy.

Upgrading to FortiGate 80F 360 Protection is essential to:

- Maintain real-time protection against evolving cyber threats such as malware, phishing, and ransomware.
- Ensure continuous firewall and security updates, reducing vulnerability exposure.
- Provide secure internet access with advanced web filtering and intrusion prevention.
- Enable 24x7 technical support through FortiCare, ensuring minimal downtime in case of incidents.
- Comply with internal ICT security standards and regulatory cybersecurity requirements.
- Protect organizational systems, cloud services, and end users from unauthorized access and attacks.

The service provider is expected to provide a 12-month renewal license that includes the following:

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) “**price**” means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) “**Rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**The Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 - \frac{Pt - Pmin}{Pmin}\right) \quad \text{or} \quad Ps = 90 \left(1 - \frac{Pt - Pmin}{Pmin}\right)$$

Where

- Ps = Points scored for price of tender under consideration
 Pt = Price of tender under consideration
 Pmin = Price of lowest acceptable tender

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 + \frac{Pt - P_{max}}{P_{max}}\right) \text{ or } Ps = 90 \left(1 + \frac{Pt - P_{max}}{P_{max}}\right)$$

Where

- Ps = Points scored for price of tender under consideration
Pt = Price of tender under consideration
Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system: or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
