3. INTRODUCTION

Background

Denel is a State-Owned commercially driven Company (SOC) and provides innovative defence, security, aerospace and related technology solutions. Denel is a strategic partner to the South African National Defence Force (SANDF) and its capabilities include defence, aerospace and advanced manufacturing. Denel's defence capabilities date back to more than 70 years, when its first manufacturing plants were established.

As a major supplier of Unmanned Aerial Vehicle (UAV) systems, Denel is respected for developing and producing some of the most rugged and reliable tactical UAV surveillance systems in the world.

Denel also has design, development, engineering and integration capabilities allowing it to offer advanced precision-guided missiles, combat systems, turrets, infantry weapons, including long-range mortars, a comprehensive range of small, medium and large calibre ammunition, a range of armoured vehicles and aerospace systems. It also offers aircraft MRO, technical training, mine clearing, contraband detection and multi-purpose testing facilities.

4. PURPOSE OF THIS REQUEST FOR PROPOSAL (RFP)

The Denel SOC Ltd. requires an Integrated Paterson Points web-based job evaluation and profiling system for 4 users for a minimum 3-year period. This is an ongoing requirement

5. LEGISLATIVE FRAMEWORK OF THE BID

6. Tax Legislation

1.1.1 Bidder(s) must be compliant when submitting a proposal to Denel SOC Ltd and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

- 1.1.2 It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
- 1.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.
- 1.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 1.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.
- 1.1.6 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

- 1.4 Any communication to an official or a person acting in an advisory capacity for Denel SOC Ltd in respect of the bid between the closing date and the award of the bid by the Bidder(s) is discouraged.
- 1.5 All communication between the Bidder(s) and Denel SOC Ltd must be done in writing.
- 1.6 Whilst all due care has been taken in connection with the preparation of this bid, Denel SOC Ltd makes no representations or warranties that the content of the bid or any information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. Denel SOC Ltd, and its employees and advisors will not be liable with respect to any information communicated which may not accurate, current or complete.
- 1.7 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by Denel SOC Ltd (other than minor clerical matters), the Bidder(s) must promptly notify Denel SOC Ltd in writing of such discrepancy, ambiguity, error or inconsistency in order to afford Denel SOC Ltd an opportunity to consider what corrective action is necessary (if any).
- 1.8 Any actual discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by Denel SOC Ltd will, if possible, be corrected and provided to all Bidder(s) without attribution to the Bidder(s) who provided the written notice.
- 1.9 All persons (including Bidder(s)) obtaining or receiving the bid and any other information in connection with the Bid or the Tendering

13. COUNTER CONDITIONS

- 1.11 Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions will result in the invalidation of such bids.

14. FRONTING

- 1.12 Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the Government condemn any form of fronting.
- 1.13 The Government, in ensuring that Bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, be established during such enquiry / investigation, the onus will be on the Bidder / contractor to prove that fronting does not exist. 17. PRESENTATION / DEMONSTRATION

Denel SOC Ltd reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process.

18. DURATION OF THE CONTRACT

Three (3) years contract.

19. GENERAL CONDITIONS OF SPECIFICATION

- All intellectual proprietary rights emanating from this project will reside with Denel.
- All reports and working paper files shall become the property of Denel.
- The prospective service providers must submit an all-inclusive price and detailed cost breakdown schedule (the price must be VAT inclusive).
- Travelling costs and time spent or incurred between the service provider offices and Denel or home and office the staff shall not be for the account of Denel
- Payment will be strictly based on completed and approved deliverables and time spent and not only based on time spent at Denel.
- The successful bidder will be expected to conduct themselves in a manner that will be seen as part of Denel.

20. SCOPE OF WORK

The purpose of this RFT is to obtain proposals from suitably qualified and experienced web-based job profile and evaluation web-based system companies.

- Provide cross-correlation options with other grading systems
- Web-based – constant access and automatic updates
- Provide flexible On-line Help and System support
- Track history
- Store all documentation on system
- Save incomplete Job evaluation sessions

- External Job Evaluation validations for 1 year
- Provide status report on Job evaluation sessions
- Denel is looking to for a web-based system that can:

 - provide accurate market-related grades (including modal grades) that is fully integrated with the Organised Framework for Occupations (OFO) reporting standard;
 - provide analytical capabilities to view the Company's data in comparison to the market;
 - reflect comprehensive information on the remuneration elements per position and across all levels in the organisation;
 - filter by the jobs that exist in your company, or access the full database of jobs;
 - provide salary information for positions in Paterson grades.

 - During this phase Bidders' responses will be evaluated based on compliance with the listed expectations and criteria as in Clause 5:
 - Reputable and highly experienced specialist in remuneration with national and international capability

21. EVALUATION AND SELECTION CRITERIA

First Stage: Technical Evaluation Criteria

Disqualifying Criteria

Due to the sensitivity and nature of the data, and how it may impact company decisions as well as employee livelihoods, it is important for Denel to work with a reputable database. To this end, the tenderer must submit proof of clean audits on the salary survey data for the past

5 years. Should they not be in a position to do so they will be disqualified from the process.

Only those Tenderers which score **80 points or higher (out of a possible 100)** during the technical and site visit evaluation will be evaluated during the second stage of the Tender. Tenderers are required to submit supporting documentation as testimony to their compliance with each requirement, where applicable.

The Technical Criteria that will be used to test the capability of Tenderers are as follows:
