CLAIMS DESKTOP APPLICATIONS PORTING AND MIDDLEWARE DEVELOPMENT

ORIGINATION MODULE

This module will enable the RAF business to originate claims lodged via different claims lodgement channels. This is the first stage of claim registration within the RAF. It involves the submission of statutory claims documents in compliance with the claims procedure manual. At this stage of the claims processing, most of the tasks are to capture the claims details as received from the claimant. The system must perform validations of these details based on the existing data model to improve data quality and data consistency.

CLAIMS DETERMINATION MODULE

This module will enable the RAF business to settle claims that have reached the claims adjudication stage. This phase deals with the quantum determination, drafting of offers and creation of payment requests. This is the final stage(s) of claim processing before settlement and finalization of a claim. There's an electronic document exchange between the parties involved in a claim. Once payment requests have been made on a claim, the process moves towards the ERP module (SAP) of claims payment. The system must comply with the mandates defined in the delegation of authority framework to execute tasks assigned in the claims workflow. The workflow has predefined timelines on when some actions need to be performed in compliance with the Claims procedure manual.

LITIGATION MODULE

This module will enable the business to process claims that are litigated as a way of settlement. This stage of claim processing deals with settling disputes between the RAF and the claimants regarding their lodged claims. It involves the exchange of legal documents and information pertaining to the disputed facts of a claim. It is one of the prolonged processes in claims settlement and its workflow is dependent on the outcomes of a legal process. The RAF has a Litigation Management System (Web based), which deals with Summons Management. This module will integrate with that module to extract data captured at the inception of the litigation process.

POST-SETTLEMENT MODULE

This module will enable the RAF business to process payment of invoices, caregivers and undertakings emanating from settled claims. This process is meant for claimants who have been identified as requiring ongoing support from the RAF through the assessment of their medical needs. It involves the submission of invoices and timesheets to request compensation for the services rendered to claimants who have an RAF undertaking for continued support. The system must perform validations of an existing RAF undertaking and contract to process these invoices.
