### 9 Specification

### 9.1 <u>PURPOSE/OBJECTIVE</u>

- The purpose of this document is to source a service provider to supply, install and configure the cloudbased software testing tool furthermore assist with setting up the testing function, provisioning of Quality Assurance (QA) and testing services to be contracted for testing software solution.
- TFR ICTM is in the process of adopting DevOps methodology to accelerate software delivery while balancing cost, quality and risk. For TFR ICTM to implement programs that will derive maximum benefits, effective end-to-end software testing capability is required which comprehensively cover process in the entire software development cycle (planning, design, creation and execution of test cases, support for existing test cases and test environments).
- The testing tool will be used by the Portfolio team of 10 users.

#### The objectives of a comprehensive end-to-end software testing capability are as follows:

- **Verification:** Confirms that the software performs the various business and technical requirements stated by the client.
- **Validation:** Confirms that the software performs as expected and as per the requirements of the clients.
- **Quality Analysis:** Testing helps improve the quality of the software by constantly measuring and verifying its design and coding.
- **Compatibility and Usability:** Validate application's compatibility with the implementation environment, various devices, operating systems, user requirements etc.
- Verifying Performance & Functionality: Ensuring the software has exceptional performance and functionality.

#### 9.2 <u>CONFIDENTIALITY</u>

• A fundamental requirement of the procurement process is that tender information is always kept confidential. No team member or stakeholder are allowed to communicate these technical specifications to anyone outside of the process.

#### 9.3 EQUIREMENT AND TECHNICAL SPECIFICATION

- TFR has adopted the V-Model also called Verification and Validation model which is a software development life cycle (SDLC) model where execution of processes happens in a sequential manner in a V-shape.
- The V-Model is an extension of the waterfall model and is based on the association of a testing phase for each corresponding development stage. This means that for every single phase in the development cycle, there is a directly associated testing phase. This is a highly disciplined model, and the next phase starts only after completion of the previous phase. The model has two phases the verification phase and the validation phase.

### The verification phase comprises of the following:


- **Requirement design:** This is the first phase in the development cycle where the requirements are solicited and documented. This phase involves detailed communication and engagements with business to understand the expectations and exact requirements. The acceptance test design planning is done at this stage as business requirements can be used as an input for acceptance testing.
- **System design:** once clear and detailed requirements are in place, system design process starts where components, modules, interfaces, and data for a system to satisfy specified requirements are defined and detailed. On this phase the system test plan is also developed based on the system design. Doing this at an earlier stage leaves more time for the actual test execution later.
- Architecture design: Architectural specifications are understood and designed in this phase. Usually
  more than one technical approach is proposed and based on the technical and financial feasibility the
  final decision is taken. The system design is broken down further into modules taking up different
  functionality. This is also referred to as High Level Design (HLD) or conceptual design. The data transfer
  and communication between the internal modules and with the outside world (other systems) is clearly
  understood and defined in this stage. With this information, integration tests can be designed and
  documented during this stage.
- **Module design:** In this phase, the detailed internal design for all the system modules is specified, referred to as Low Level Design (LLD) or logical and physical designs. It is important that the design is

compatible with the other modules in the system architecture and the other external systems. The unit tests are an essential part of any development process and helps eliminate the maximum faults and errors at a very early stage. These unit tests can be designed at this stage based on the internal module designs.

Coding: The actual coding of the system modules designed in the design phase is taken up in the Coding phase. The best suitable programming language is decided based on the system and architectural requirements. The coding is performed based on the coding guidelines and standards. The code goes through numerous code reviews and is optimized for best performance before the final build is checked into the repository.

#### The validation phase comprises of the following:

- Unit test: Unit tests designed in the module design phase are executed on the code during this validation phase. Unit testing is the testing at code level and helps eliminate bugs at an early stage, though all defects cannot be uncovered by unit testing. Several effective testing techniques are usable in unit testing stage. The unit testing techniques may be broadly divided into three types: functional testing, structural testing, and heuristic or intuitive testing.
- **Integration test:** Integration testing is a systematic technique for constructing the program structure while at the same time conducting tests to uncover errors associated with interfacing. The objective is to take unit tested components and build a program structure that has been dictated by design and test the coexistence and communication of the internal modules within the system. Integration testing is associated with the architectural design phase.
- System test: System testing is directly associated with the system design phase. System testing of software or hardware is testing conducted on a complete, integrated system to evaluate the system's compliance with its specified requirements. System testing falls within the scope of black box testing, and as such, should require no knowledge of the inner design of the code or logic System testing is actually a series of different tests whose primary purpose is to fully exercise the computer-based system. Although each test has a different purpose, all work to verify that system elements have been properly integrated and perform allocated functions. Some of Different types of system testing are as follows: recovery testing, security testing, graphical user interface testing, and compatibility testing.
- Acceptance test: Acceptance testing is associated with the business requirement analysis phase and involves testing the product in user environment. Acceptance testing (also known as user acceptance testing) is a type of testing carried out to verify if the product is developed as per the standards and specified criteria and meets all the requirements specified by business. This type of testing is generally carried out by a user/customer where the product is developed externally by another party.



The successful bidder shall be required to conduct the outlined activities on the TFR Environment

### The solution must provide the following capabilities:

- **Unit/ functional testing:** Checking functions by emulating business scenarios, based on functional requirements.
- **Performance testing:** Testing how the software performs under different workloads. Load testing, for example, is used to evaluate performance under real-life load conditions.
- Security testing: Security testing makes sure that only the authorized personnel can access the program and only the authorized personnel can access the functions available to their security level. The security testing is performed to check whether there is any information leakage in the sense by encrypting the application or using wide range of software's and hardware's and firewall etc.
- **Stress testing:** Testing how much strain the system can take before it fails. Considered to be a type of non-functional testing.
- **Automated testing:** Also called dynamic testing is the application of software tools to automate a human-driven manual process of reviewing and validating a software product. The tester runs the script on the testing tool and testing is done.
- **Manual testing:** Also called static testing is the process of manually testing software for defects. It requires a tester to play the role of an end user whereby they use most of the application's features to ensure correct behaviour. It is done in early phase of the lifecycle by an analyst, developer and testing team. Different manual testing techniques are as follows: walk through, informal review, technical Review, and inspection.
- **Integration testing:** Ensuring that software components or functions operate together.

• **Compliance testing/ System testing:** of software or hardware is testing conducted on a complete, integrated system to evaluate the system's compliance with its specified requirements.

### The successful bidder shall provide a testing tool that:

- Support cloud-based testing (Preferred), cloud infrastructure offers a convenient solution unlike other test environments which can be difficult and expensive to build and maintain.
- Support mobile application testing
- Centralized repository to store and manage all the updated version of test cases, and test data.
- Enables testing metrics, dashboards, and analytics
- Integrates with other technologies, and a wide range of application lifecycle tools.

### The successful bidder shall be required to:

- Conduct the outlined activities on the TFR Environment.
- Conduct a comprehensive system walkthrough of the solution, as specified within the scope of
- work.

### 10 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

### 11 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

### 12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. ### 13 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.



- 1.2 The value of this bid is estimated to not exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 preference point system shall be applicable. Despite the stipulated preference point system, Transnet shall use the lowest acceptable bid to determine the applicable preference point system in a situation where all received acceptable bids are received outside the stated preference point system.
- 1.3 Either the 80/20 preference point system will be applicable to this tender.
- 1.4 Preference points for this bid shall be awarded for:
  - (a) Price;
  - (b) B-BBEE Status Level of Contribution.
  - (c) Any other specific goal determined in Transnet preferential procurement policy.
- 1.5 The maximum points for this bid are allocated as follows:

- 1.6 Failure on the part of a bidder to submit proof of specific goals together with the bid will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.7 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

### 2. **DEFINITIONS**

(a) "all applicable taxes" includes value-added tax, pay as you earn, income tax, unemployment

insurance fund contributions and skills development levies;

- (b) **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (c) "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (d) "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the supply/provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- (e) "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (f) **"EME"** means an Exempted Micro Enterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (g) **"functionality"** means the ability of a bidder to provide goods or services in accordance with specification as set out in the bid documents;
- (h) "Price" includes all applicable taxes less all unconditional discounts.
- (i) "Proof of B-BBEE Status Level of Contributor" means:
  - 1) B-BBBEE status level certificate issued by an unauthorised body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act.
- "QSE" means a Qualifying Small Enterprise in terms of a Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (k) **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties.
- (I) "Specific goals" means targeted advancement areas or categories of persons or groups either previously disadvantaged or falling within the scope of the Reconstruction and Development Programme identified by Transnet to be given preference in allocation of procurement contracts in line with section 2(1) of the PPPFA.

### 3. POINTS AWARDED FOR PRICE

### 3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

$$Ps = 80 \left( 1 - \frac{Pt - P\min}{P\min} \right)$$

Where

- Ps = Points scored for comparative price of bid under consideration
- Pt = Comparative price of bid under consideration
- Pmin = Comparative price of lowest acceptable bid

In terms of Transnet Preferential Procurement Policy (TPPP) and Procurement Manuals, the following preference points must be awarded to a bidder who provides the relevant required evidence for claiming points

- 4.3 A trust, consortium or joint venture (including unincorporated consortia and joint ventures) must submit a consolidated B-BBEE Status Level verification certificate for every separate bid.
- 4.4 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 4.5 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.

- 4.6 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
- 4.7 Bidders are to note that the rules pertaining to B-BBEE verification and other B-BBEE requirements may be changed from time to time by regulatory bodies such as National Treasury or the DTI. It is the Bidder's responsibility to ensure that his/her bid complies fully with all B-BBEE requirements at the time of the submission of the bid.
