1. PURPOSE

The purpose of this exercise is to appoint a service provider for the provision of Editing, Proofreading, Design, Layout and Printing of Annual Performance Plan (APP) Document for 3 Years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The Service Provider will render the following:

Editing, Proofreading, Design, Layout and Printing of Annual Performance Plan (APP) Document for 3 Years

Editing and Proofreading:

- Upon appointment, the supplier is to provide a project plan
- Using a qualified writer, editor and proof-reader with fluent English language and communication skills
- Ensures that the document is rewritten where required, edited and proofread – ensure that document is grammatically correct, with no typos and spelling errors and the flows from a story perspective.
- Content and images will be provided to the supplier by SANParks.
- Allow for 5 rounds of edits

Design and Layout:

- Present three concepts for the document (covers) from which one will be selected.
- Design and layout of document for final sign off by SANParks.
- Supplier is to adhere to CI manual which will be provided by SANParks.
- Submit electronic version of the final document
- Submit a final print ready document for sign-off before printing
- Submit printed proof for sign-off before printing

Printing:

Print and binding the document as per the specifications outlined.

- Approximately 200 pages, printed in full colour, on white 128gsm matt paper
- Size:297mmx210mm (A4)
- Cover 4pp printed full colour on 300gsm matt and gloss laminated 1 side

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
