BACKGROUND

The Nuclear Medicine Department manufactures high-grade radiopharmaceuticals used for diagnostic applications in nuclear medicine. The radiopharmaceuticals are produced under Good Manufacturing Practice principles and as per the requirements of the South African Pharmacy Council and South African Health Products Regulatory Authority (SAHPRA). The Nuclear Medicine Department furthermore has distribution agreements with companies around the world necessitating the supply of a consistently high-quality product.

The production of Germanium68, Sodium22 and Strontium82 radioisotopes starts with the encapsulation of cold material (Gallium, Magnesium and Rubidium Chloride respectively) within Niobium metal capsules – hereafter known as Production Targets. During the irradiation process the Niobium encapsulated Production Targets are irradiated with a proton beam and water cooled in order to produce the required radioisotopes. The sealing of the Production Targets capsules as per attached drawings is accomplished using electron beam welding techniques. The integrity of the finished electron beam welded Production Targets are verified by Computed Tomography Scanning.

DETAILED SCOPE OF WORK

iThemba LABS seeks to appoint a service provider capable of performing the Electron Beam Welding services to fulfil the following requirements:

1. Electron Beam Welding of Production Targets

The service provider must be able to perform the Electron Beam Welding services of the Production Targets as per the following criteria:

- a) Complete electron beam weld seal width 0.5 mm
- b) For the Gallium Production Target: No Gallium creep within the 0.5 mm seal (will be checked by CT Scanning)
- c) Perform Helium leak test to check integrity of the seal
- d) Provide certification as to validity of the Helium leak test
- e) Ensure Capsules are free of any scratches, dents and distortion

The shipping cost of the targets: iThemba LABS will be responsible for the courier of the targets to and from the service provider premises.

The Electron Beam Welding Services of these Production Targets will be for up to 100 targets per annum on an as-and-when-required basis over the duration of the contract (36 months) See attached drawings for dimensions and specifications.

2. Research and Development of new Production Targets

iThemba LABS is developing and expanding their range of radiopharmaceuticals and requires research and development (R&D) services in the field welding, Electron Beam Welding and metallurgy in order to develop the next generation of Production Targets.

The service provider should be able to provide the following services:

- R&D welding processes to join ferrous metals, light metals, precious metals and alloys. Examples include Niobium and Inconel 625
- R&D the welding of these materials with techniques including but not limited to Gas Tungsten Arc Welding (TIG), Gas Metal Arc Welding (MIG), Shielded Metal Arc Welding (SMAW), Sub Arc Welding (SAW) and Electron Beam Welding (EBW)
- Consultation and design services in welding, metallurgy and engineering and fabrication

The service provider must submit a company profile and portfolio that demonstrates their welding capabilities, skills, and certifications/qualifications.
