1. INTRODUCTION AND PURPOSE

Quotation for the supply, delivery and offloading of nursery growth media and plant containers for Nursery Operations as and when required for a period of 1 year. These are the Nurseries growth media and plant containers required for the nursery over the next year for plant production.

2. BACKGROUND

Nursery Operations uses various growth media and plant containers for the propagation and cultivation of various plants. These plants are grown by Nursery Operations and when the plants have grown big enough, they are then planted in the tourist parks, urban parks, traffic islands and as street trees.

The growth media and plant containers are required by Nursery Operations of the Environmental Management and Parks Division.

The benefiting Divisions are the Environmental Management and Parks, and the Agriculture and Rural Development.

The ornamental plants produced will be plant in parks, public open spaces and streetscapes and therefore improve on the beautification of the City. The vegetable seedlings produced are supplied to the Agriculture and Rural Development Division, for food production programs.

The City as a whole will benefit as a beautiful, green city is known to attract tourists and indirectly contribute to the economy of the city.

3. PROJECT SCOPE AND DELIVERABLES





The following nursery growth media and plant containers are required:

ITEM 1: VARIOUS GROWTH MEDIA

The following requirements must be met:

- The items must be free from Weeds, insects and disease
- None of the declared weeds and invaders as listed in the Conservation of Agricultural Resources Act, 1983 (Act no 43 of 1983) and its amendments



- NO regran (RECYCLED) plastic will be accepted. The tenderer must guarantee this, and all plastic bags and plastic sheeting must be replaced at their cost.
- The plastic must comply with the minimum micron thickness required. It may be thicker but not thinner.
- All containers must be 100% manufactured in South Africa.

4. EVALUATION CRITERIA

The bid will be evaluated in four stages. The evaluation will be done as follows:

Stage 1: Administrative requirement

Stage 2: Mandatory

Stage 3: Preferential Point System

4.1 ADMINISTRATIVE COMPLIANCE

All the bids will be evaluated against the administrative responsiveness requirements as set out in the list of returnable documents.

All items must be bid on to qualify for evaluation. All sub-items under tables 1 and 2 must be quoted for.

4.2 MANDATORY COMPLIANCE

Bidders must comply with the following mandatory requirements:

- A signed letter from a South African Supplier/Manufacturer/ Distributor must be attached from the suppliers of item 2.1 to 2.8 confirming that virgin plastic bags will be supplied and item 2.9 confirming the density of the polystyrene trays. (it must be on the manufacturer/distributors letter head).
- Prospective bidders must have experience and knowledge in supply and delivery of nursery growth media and plant containers for Nursery Operations with satisfactory performance over a period of time. The bidder should attach a letter of reference and/or completion certificate indicating an organisation or businesses with contactable references that have been supplied to.

4.3 PREFERENTIAL POINT SYSTEM

The preferential points to be used will be the 80/20 system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2017.

- 80 points for price
- 20 points for B-BBEE status (service provider to submit the certified copy of the B-BBEE level rating certificate).

5 VALIDITY PERIOD

The validity period for the quotation after closure is 90 days.

6 PRICING SCHEDULE

The CoT reserves the right to accept all items or only selected ones as determined by the available budget.

The following requirements must be met:

- The price must include transport, delivery and off loading

- 1.5 Failure on the part of a bidder to submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS), or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or a sworn affidavit confirming annual turnover and level of black ownership in case of an EME and QSE together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- (b) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (c) **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (d) **“bid”** means a written offer in a prescribed or stipulated form in response to an

invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;

- (e) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) as amended by Act No 46 of 2013;
- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- (g) **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- (h) **“contract”** Error! Bookmark not defined. means the agreement that results from the acceptance of a bid by an organ of state;
- (i) **“EME”** means an Exempted Micro Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
