RESPONSES TO CLARIFICATION QUESTIONS:

1. **Handling Liquidated Companies:** If a reference company has liquidated, suppliers should submit the last available reference letter and proof of liquidation. The Chairperson agreed to consult governance for further guidance and provide clarification in the minutes.

RESPONSE: The criteria as per the RFP document is "reference letters for work done in the previous five years". The order for work done is not part of the advertised evaluation criteria and amending the evaluation criteria at this stage would be unfair to other bidders, resulting in irregular expenditure.

Unless the person can get a reference letter from the liquidated company with all the requirements as advertised, they will have to be allocated zero for the specific experience/reference letter.

2. **SAPCA Registration and Certification:** Suppliers questioned the mandatory SAPCA registration, noting it is an association rather than a statutory body. The Chairperson and the End-User agreed to review this requirement and clarify in the minutes.

RESPONSE: SAPCA it's an association of registered pest control operators and acts as the voice for the pest control industry in South Africa.

3. **Snake Transfer and Capture Permits:** Suppliers sought clarification on snake transfer certificates, with The Chairperson and the End-User confirming the need for catch and release permits and hazardous waste transport certificates and agreeing to research regional permit requirements for further guidance.

RESPONSE: The successful service provider must have a permit for each province but for evaluation only one permit is required irrespective of the province.

4. **Ad Hoc Services Pricing and Procedures:** Suppliers raised concerns about pricing accuracy for ad hoc services. The Chairperson and the End-User agreed to estimate costs based on historical data and address variations through compensation events, with further details to be provided in revised schedules.

RESPONSE: Ad hoc services added on consolidated prices sheet. Revised Annexure A pricing schedule to be uploaded on Transnet Portal and National Treasury's e portal.
