C3 SCOPE OF WORK

C3.1 BACKGROUND

Dr JS Moroka Local Municipality provides water services across the municipality.

REQUIREMENTS AND SCOPE OF WORK

DRJSMLM hereby seeks to procure and appoint a panel of service providers for replacement, repair and maintenance of bulk water infrastructure as and when required for a period of 36 months.

3.1.2 Replacement, repair and maintenance of bulk water infrastructure.

The provision of replacement, repair and maintenance of bulk water infrastructure will assist in timeous completion of maintenance and repair works and improve infrastructure operation.

C3.2 DESCRIPTION OF THE WORKS.

3.2.1 Employer's objectives

The objective of the works is to:

The objective of the tender is to find suitably qualified and experienced service provider to provide services of Replacing, repair and maintenance of bulk water infrastructure in the bulk water supply system in the Dr JS Moroka Local Municipality.

- a) The existing infrastructure is approximately 40 years.
- b) The infrastructure is not in a good condition due to various reasons which relates to technicalities, vandalism.
- c) Break down of **Some** components shown below.
 - Pipeline 1(pressurised)- Bloedfontein Supply system- 400mm and 350 mm-
 - Pipeline 2(pressurised)- Kuilen supply system -300mm
 - Pipeline 3-(pressurised)- Kameelrivier supply system-300mm
 - Pipeline 4-(pressurised)- Walkraal supply system-700mm
 - **And other bulk supply systems.**

3.2.2 Scope of work

- a) Visual condition assessment and assessment report.
- b) Assessing and observing the filling of pipeline with water.
- c) Condition assessment and scope of work report.
- d) Determine and report on the remaining useful life of the completed assests.
- e) Determine and report on the long term system integrity and /or sustainability.

3.3 Services

Service Standards, Compliance and Contract Management

The contract will be for a period of 36 months (although final duration may be subject to relevant considerations by the DRJSMLM).

1.1.1. The Contractor will be required to ensure that the solutions proposed in the bid are in line with the industry norms and standards, including but not be limited to the designs and developments in the market.

1.1.2. A formal contract will be entered into with the successful Bidder ("The Contractor") and the contract will be managed in accordance with the MFMA (section116), whereby contracts procured in terms of the supply chain management system of a municipality must be in writing and stipulate the terms and conditions thereof.

1.1.3. The Contractor will be required to maintain compliance with relevant service levels and to report any non-compliance detected to the DRJSMLM. DRJSMLM will use the reports or documentation provided by the Contractor as well as its own records to confirm instances of non-compliance and levy the applicable penalties occurring due to the Contractor's indefensible failures.

1.1.4. Bidders should note that penalties will be implemented by the DRJSMLM in order to ensure compliance to agreed service levels. The Contractor will be penalised for failure to provide the services or to meet the service levels agreed to between the parties, where the failure is as a result of the Contractor's own fault or negligence.
