

SECTION 2.2 SPECIFICATIONS**THE APPOINTMENT OF A PANEL OF SERVICE PROVIDERS FOR THE PROCUREMENT OF ROAD CONSTRUCTION EQUIPMENT / CONSTRUCTION VEHICLES AND MATERIALS FOR ROAD CONSTRUCTION FOR A PERIOD OF THREE (3) YEARS (IF AND WHEN REQUIRED)****2.2.1 Employer's objectives**

The Employer's objectives are to provide an acceptable and consistent level of service by maintaining all its assets for the benefit of the public.

2.2.2 Work specifications

The extent of the works includes the hiring of construction vehicles with operators.

The Municipality intends to establish a framework agreement with the service providers to ensure seamless uninterrupted service delivery. Under this framework agreement, the municipality envisions to rely on the professional services of ethical service providers who shall, from time to time, be requested to provide a secondary layer of support to the municipal resources. It is within that scope that service providers shall be requested to hire construction vehicles and/or earth moving equipment, and any other services as maybe required to ensure service delivery is not hindered.

This description of the works is not necessarily complete and shall not limit the work to be carried out by the contractor under this contract. The Employer will identify works required. It will be up to the Contractor to prove or justify any work other than that identified needs to be done in his opinion. Such additional work must be approved before commencement.
