## 1. SCOPE OF WORK

### 1.1. DESCRIPTION

## 2. BACKGROUND

Rand Water is a bulk water distribution company supplying portable drinking water to mainly Gauteng province and surrounding areas in proximity. It currently supplies over 4500 ML/day through its vast pipeline network spanning over 3500 km's.

As part of its operations, flow meters are an important tool used to measure the amount of water supplied to its customers and detect any water loss anomaly's, this is referred to as the water balance report. Rand Water uses various flow meters depending on the pipe size, and the category use of a pipe. For bulk water distribution pipes with diameters above 600mm, Rand Water uses magnetic flow meters. Mechanical flow meters are commonly found within the purification plant on pipes with diameters ranging from 200 mm to 600 mm, these pipes are usually carriage and fire hydrant water pipelines.

Magnetic and mechanical flow meters are invasive of the pipeline, they are installed by cutting the pipe open and inserting a magnetic/mechanical flow meter with an equal diameter to the pipe, the meter is connected to the pipe by flanges.

Lastly, Mag flow/mechanical meters decrease in accuracy when foreign materials are found within the pipe.

## 3. PROBLEM STATEMENT

Due to the invasive installation method of magnetic/mechanical flow meters, the operations, Asset management, and maintenance departments face the following challenges with mag flows:

- A. Maintenance is unable to repair mag-flows/mechanical meters that are faulty, a plant shutdown is required to access the flow meter and Rand Water cannot afford disruptions to operations due to high water demands.
- B. Furthermore, unmaintained, faulty mag flow meters present inaccurate, inconsistent recordings/readings of water flow rates. This may result in undetected water leaks, over or underbilling of customers or no billing at all.
- C. The procurement and installation of new mag-flows to replace old ones or augment those available have many challenges for the Strategic Asset Management (SAM) division. Compared to non-invasive flow meters, mag-flows have longer lead time on manufacturing and procurement. They are intrusive to daily operations when installing, and the internal supply chain delays with all-other supporting engineering processes required to successfully install a mag-flow make it a complex engineering project e.g., Crane hiring and access to remote locations for machinery.

Previous generations of non-invasive flow meters required an adhesive gel between the pipe and transducer (flow reading sensor) to obtain the flow rate readings. When the gel dried, this made the technology inapplicable for the permanent installation of non-invasive flow meters because the readings were inaccurate.

For Rand Water to continue to monitor their bulk distribution network effectively, the challenges faced by operations, maintenance and SAM need to be addressed to ensure the sustainability of its business case.

## 4. PROJECT AIM

Rand Water aims to test the effectiveness and reliability of non-invasive ultrasound flow meters on its bulk water distribution pipelines.

## 5. PROJECT OBJECTIVES

The project objectives are as follows:

- A. Evaluate the reliability and effectiveness of non-invasive flow meters.
- B. Improve the accuracy of its water balance monitoring.

## **6. SCOPE OF WORK**

- A. Establishment of site (Excavation, zoning SHEQ requirements)
- B. Full installation of non-invasive flow meter to industry standard. Pipe diameter ranging between 600 mm to 2500mm (includes any calibration requirements)
- C. Rehabilitation of surrounding vegetation after site work
- D. Data collection and analysis
- E. Present a business case report.

## **7. KEY PERFORMANCE INDICATOR**

The following will be measures of a successful pilot:

- A. High accuracy of flow meter readings
- B. Ease of installation. Permanent coupling pad.
- C. Installed equipment contains temperature compensation as per ASME MFC-5, IP 68 compensation, and or IP 66 requirements (with armored cable)
- D. No disruptions to daily operations e.g., no shutdown shall be granted. D. Rehabilitation of environment.
- E. Rehabilitation of the environment
- F. Temperature compensation as per ASME MFC-5 to prevent measurement drift due to temperature changes. The transducer coupling material must be permanent and made of solid material and not paste or grease.
- G. Factory calibration of transmitter and transducers. The transmitter must allow for b-directional measurements. The transmitter must automatically recognize the attached transducers and load their calibration data. The transmitter must be parameterized via USB-C. Event-based triggering of data recording can be programmed. The transmitter must have alarm functions for threshold exceedances and flow direction changes. The transmitter should be pre-calibrated and delivered with an associated calibration certificate.

## **8. SITE LOCATION**

The piloting plants are Zwartkoppies and Vereeniging stations.

## **9. IMPORTANT REQUIREMENTS OF THE SERVICE PROVIDER**

- A. The service provider shall inform the Rand Water Project Manager of all changes to this project for acceptance, prior to implementation.
- B. Establish and discuss any unknown risk associated with technology deployment.
- C. Procures the required labour, services, plant, and material required to perform the required services.
- D. The service provider shall ensure and meet the SHEQ requirements of Rand Water whilst performing this service.

## **10. AWARDING STRATEGY**

The maximum number of suppliers to be awarded this RFQ is One.

## **11. EVALUATION CRITERIA**

The RFQ will be evaluated based on the criterion below:

### **11.1. Test for Responsiveness/ Pre- qualification**

### 13. GENERAL TERMS AND CONDITIONS

The following terms and conditions shall apply to the award. The Supplier agrees to adhere to the terms and conditions.

#### 13.1. DEFINITIONS

- 13.1.1. In the General Conditions of Purchase, the terms below shall have the following meanings, unless it is inconsistent with the context of the Purchase Order:

"PURCHASE ORDER"	means the order between Rand Water and the Supplier;
"DELIVERY"	means delivery in accordance with the conditions of the Purchase Order at the stated delivery point;
"SUPPLIES"	means any services, equipment, goods, items or materials to be delivered by the Supplier in terms of the Purchase Order;
"SUPPLIER"	means the party appointed by Rand Water and with whom Rand Water places the Purchase Order.

#### 13.2. FIXED PRICE

The price stated in the Purchase Order shall be regarded as fixed and is invariable and not subject to adjustments unless otherwise agreed between the parties in writing.

#### 13.3. DELIVERY TIME OR DATE

The delivery time or date stated in the Purchase Order shall be regarded as fixed and the Supplier shall adhere strictly thereto. Rand Water reserves the right to cancel any order issued if delivery is not made as agreed and the Supplier will not be entitled to any cancellation fees.

#### 13.12. FORCE MAJEURE

Any Force Majeure event experienced by the Supplier that is likely to affect the timeous delivery of any items on the Purchase Order shall be communicated to Rand Water in writing within forty-eight (48) hours of the Supplier becoming aware of such circumstance. Force Majeure event means:

- natural disasters
- war, act of foreign enemies
- riot, civil commotion
- strike, lockout, other labour disturbance (including those involving the Supplier's employees) or any other circumstances beyond the control of the Supplier and which in the absence of this paragraph will operate to frustrate the timeous delivery of the item and/or service.

#### 13.13. WARRANTY

- 13.13.1. The Supplier warrants that all goods and Services supplied under this Purchase Order will be in accordance with all contract requirements and free from defects or inferior materials, equipment, and workmanship for twelve (12) months after final acceptance of the goods or Services.
- 13.13.2. If Rand Water finds the warranted goods or Services need to be repaired, changed or re-performed, Rand Water shall so inform the Supplier in writing and the Supplier shall promptly and without expense to Rand Water replace or satisfactorily correct the goods or Services.
- 13.13.3. Any goods, services or parts thereof so corrected, shall also be subject to the provisions of this Clause, and the warranties for such goods, Services or part thereof shall be for twelve (12) months from the date of Rand Water's final acceptance of such corrected goods or Services.
- 13.13.4. The Supplier further warrants the goods/services will meet and are suitable for the purpose intended. These warranties shall survive inspection, acceptance, and payment. Goods/services that do not conform to the above warranties may, at any time within 12 months after delivery to Rand Water, be rejected and returned to the Supplier, and if Rand Water has incurred any expenses as a result thereof, Rand Water will be entitled to recover same from the Supplier.

#### 13.14. TERMINATION FOR CONVENIENCE

Rand Water reserves the right, at any time, in its own best interest,

#### 13.4. PURCHASE ORDER

- 13.4.1. In terms of this order Rand Water undertakes to procure, and the Supplier undertakes to supply the products and/or services as contained on the Purchase Order. This however, does not prohibit Rand Water to procure additional products/services, and or to procure the same/similar products/services, from any other Supplier.
- 13.4.2. The Purchase Order number stated in the Order shall be indicated clearly on all documentation to be issued by either party to the other.

#### 13.5. CANCELLATION OF ORDER

- 13.5.1. Should the Supplier fail to deliver the goods at the time agreed to, or should it not comply with any other essential condition of the Purchase Order, Rand Water shall be entitled in writing to cancel the Purchase Order, without any adverse cost implications for Rand Water.
- 13.5.2. The aforesaid cancellation shall not prevent Rand Water from exercising any of its rights available in terms of the Purchase Order.

#### 13.6. DISPATCH OF SUPPLIES

Rand Water shall not be responsible for any risk in and to the goods before delivery of such goods has taken place.

#### 13.7. SPECIFICATIONS

- 13.7.1. The Supplier shall ensure that the service to be rendered shall in all respects be in accordance with the requirements and stipulations set out in the Purchase Order. All materials and consumable items if applicable shall be new and unused, unless otherwise agreed to in writing.
- 13.7.2. Rand Water shall be entitled to return any goods with defects or deviations from the agreed specification within 7 days after date of delivery and will not be liable for any cost.

#### 13.8. GUARANTEE

Save for consumables, the Supplier guarantees the workmanship and materials and any components thereof will be free of any defects for a period of at least 12 (twelve) months after the acceptance thereof by Rand Water, reasonable wear and tear will be accepted.

#### 13.9. PAYMENT

**Rand Water does not allow advance payments to the Supplier.**

- 13.9.1. Payment of an invoice shall not prevent Rand Water from subsequently disputing all or any of the fees in good faith whether during or after the term of the Purchase Order.
- 13.9.2. Payments shall be effected within 30 days after submission of monthly statement.
- 13.9.3. Rand Water shall endeavour to make payment within 30 days from date of monthly statement, date of the aforesaid monthly statement should reflect the last day of the month wherein the services being invoiced were rendered.

#### 13.10. LIABILITY FOR COSTS, DAMAGES OR EXPENSES

Rand Water may deduct all costs, damages or expenses, or any other amount for which the Supplier is liable in terms of the Purchase Order, from moneys due to or becoming due to the Supplier in terms of any subsequent Purchase Orders or the contract between the Supplier and Rand Water. Rand Water is herewith irrevocably and *in rem suam* authorized.

#### 13.11. PENALTY AND PERFORMANCE CLAUSE

- 13.11.1. Should the Supplier fail to perform and make delivery in terms of the Purchase Order, exception of Force Majeure specified in Clause 8.13, Rand Water shall be entitled to impose a penalty, which shall be deducted from the payment statement. The imposition of such penalty shall not relieve the Supplier from its obligation to complete the services or from any of its obligations and liabilities under the Purchase Order.
- 13.11.2. Every day, following the day on which a Failure arose ("day 1"), that a Failure persists without being rectified, shall be deemed a new incidence of a Failure for which the Supplier shall incur a penalty deduction.

- fails to make sufficient progress with the work, thereby endangering completion of performance within the time specified; or
- fails to comply with any of the other instructions, terms, or conditions. Rand Water's right to terminate for default may be exercised if the Supplier does not cure the failure within ten (10) days after receiving the notice of such failure.

#### 13.16. AMENDMENT OF ORDER

- 13.16.2. No price adjustments shall be accepted unless stipulated in the quotation document received. The Supplier shall be obliged to supply the goods and services on the quoted prices, if the Purchase Order was placed within valid time of quotation.

#### 13.17. CESSION OF CONTRACTS

The Supplier may not, cede, delegate, relinquish or transfer to anyone his rights and/or obligations without the prior written consent of Rand Water.

#### 13.18. DISPUTE RESOLUTION

All disputes between the parties shall, when all efforts to resolve such dispute by negotiation have failed shall be resolved by way of arbitration under the auspices of the Arbitration Foundation of Southern Africa ("AFSA") as per AFSA's rules, in Sandton, Johannesburg. Either party shall however be entitled to proceed to the South Gauteng High Court (to which jurisdiction the parties hereby consent) for any urgent, interim or interdictory relief, as that party may deem necessary in the circumstances in order to protect its rights or interests under a Purchase Order or these terms and conditions.

#### 13.19. DOMICILIUM CITANDI ET EXECUTANDI AND NOTICES

- 13.19.1. The Parties hereto respectively choose as their *domicilium citandi et executandi* for all purposes of, and in connection with this Agreement, the physical addresses as they appear on the Purchase Order.
- 13.19.2. Any notice to be given hereunder shall be given in writing and may be given either personally (i.e. per hand or courier) or may be sent by registered post and addressed to the relevant party at its domicile or to such other address as shall be notified in writing by either of the parties to the other from time to time. Any notice given by registered post shall be deemed to have been served on the expiry of 7 (seven) calendar days after same is posted. Any notice delivered personally shall be deemed to have been served at the time of delivery.

#### 13.20. LAW

The Purchase Order shall be governed and interpreted in accordance with the law of the Republic of South Africa and shall be subject to the jurisdiction of the South African courts to which the Supplier hereby irrevocably submits but without prejudice to Rand Water's right to take proceedings against the Supplier in other jurisdictions.
