T1.1 TENDER NOTICE AND INVITATION TO TENDER/SBD1

The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision Consulting Engineering Services for the Routine Road Maintenance of National Route N4 Section 1 & 2, N4 Sections 9, 11 & 12, N1 Section 21 & 22, R21 Section 2, R104 Sections 1 & 2 and R573 Section 1 (Tshwane Freeway RRM). This project is in the province of Gauteng and in the Tshwane Metropolitan area.

The approximate programme is for design and construction documentation to be completed by November 2026), followed by supervision of 60 months. The commencement date of the supervision phase will be communicated at the Handover meeting.

Only tenderers who are registered on the National Treasury Central Supplier Database at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
