### 1. INTRODUCTION

As of February 2024, OTP reestablished the GIS function through the appointment of Deputy Director: Spatial Planning & GIS and in September 2025, Assistant Director: GIS Analyst was appointed. The OTP Spatial Planning and GIS directorate has the mandate to transversally coordinate GIS in the province to support provincial planning, performance monitoring and manage spatial data and information for sector departments, public entities and local government, this function requires specialised GIS Technical Resources namely: GPS/GIS Field Data Collectors.

### 2. MOTIVATION

As per the appointment, one of his key performance areas (KPA) is designing, planning and performing GIS analysis to address the strategic objectives of the Province.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.



- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
- 1.7 Bidders who wish to claim points in terms of table 4.2 below need to provide proof for each point claimed as guided below:

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
