### **INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

## **BUSINESS UNIT RESPONSIBLE FOR THE BID**

Occupational Health and Safety is a division under COO that is responsible to ensure the compliance with the requirements of the Occupational Health and Safety Act 85 of 1993 as amended and international safety management standards.

For effective and efficient functionality to assist with the continual implementation and maintenance of the OHS functions within SANParks National Park. Compliance to Health and Safety is a legal requirements, hence sustainability is of importance.

Medical surveillance is required by law to be carried out in workplaces where workers are exposed to particular hazards. The particular hazards that require medical surveillance include noise, asbestos, certain chemicals, certain biological agents, and lead. It is the responsibility of the employer to ensure that the medical surveillance is carried out and the employer must pay for the service of a medical professional

## **CONTEXT OF THIS PROCUREMENT**

SANParks intends to appoint a panel of Occupational Health Service provider to comply with the country's legislation and ensure that its employees adhere to the best occupational practices and international standards. Therefore, the organization has to ensure that they source a reputable partner to assist with provision of the occupational medical services that will promote the health and safety of its employees.

The service provider(s) should have an established networks of allied medical professionals to ensure that employees have reasonable access to emergency care especially in the remote parks. This means that the service provider(s) must be as and when required available (on call) 24 /7 Hours for emergency. Administer and conduct occupational health services, injury on duty administration, disability and incapacity management as and when required by SANParks and to offers support to employees. In case of absence, the provider may appoint a locum who must be equally qualified.

Furthermore, the service provider(s) should ensure that all SANParks occupational activities are managed in an integrated manner and are fully functional, including establishing and maintaining an appropriate referral system for the individual, group or organization to variety of disciplines in medicine.

## **CONTRACT PERIOD**

The duration of this contract will be for a period of 3 years.

The work to be carried out by the panel under this contract is mainly comprised of the following:

### **OCCUPATIONAL HEALTH (MEDICAL SURVEILLANCE& HEALTH RISK ASSESSMENT)**

#### **Medical examinations**
