- reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- disqualify Quotations submitted after the stated submission deadline;
- not necessarily accept the lowest priced Quotation or an alternative bid;
- place an order in connection with this Quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the quotation process;

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful

Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

## 12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. 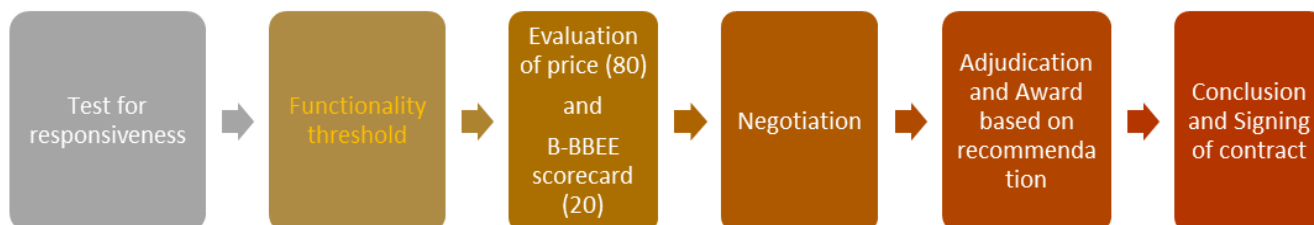

### 1.5 STEP FIVE: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
  - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
  - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

### 1. **INTRODUCTION**

Transnet Port Terminals (TPT) Port Elizabeth handles a variety of commodities, including multipurpose, automotive, containerized and bulk cargoes. In line with TPT's strategic intent and anticipated commodity movements countrywide, TPT needs to decommission and remediate the Port Elizabeth Bulk Terminal and reposition this terminal within the Port of Ngqura, to consolidate and expand its manganese handling potential.

The Port Elizabeth Bulk Terminal receives various grades of manganese, from mines inland, transported via rail to the terminal. The manganese ore is tipped onto conveyors, by means of a tippler, and conveyed to the dedicated manganese storage stockpiles within the designated storage area in the terminal, where it is stacked by means of stacker / reclaimers. Upon designated vessel arrival, the identified manganese shipment is reclaimed by the stacker / reclaimer, placed on a conveyor route and conveyed to the shiploader, located on the quayside, which loads the vessel according to shipment size.

With any bulk cargo operations, there are certain environmental impacts which are expected during the lifetime of the terminal's operations. TPT has implemented a comprehensive Operational Environmental Management Plan to mitigate against these impacts, as well as obligation to comply with the National Environment Management: Act, No.108 of 1998.

At the outset, it is anticipated that a full Environmental Impact Assessment (EIA) will be required for this project due to its proximity to sensitive coastal environments, as well as the need to obtain other necessary approvals and permits, undertake specialist studies and requisite stakeholder engagement.

It is on this basis that TPT wishes to appoint a competent and experienced Environmental Assessment Practitioner (EAP) to undertake a thorough assessment and advise as to what will be required for TPT to undertake and successfully complete the Port Elizabeth Bulk Terminal decommissioning and remediation process, in a manner that is consistent with all relevant legislation.

### 2. **SCOPE OF WORK AND DELIVERABLES**

TPT's Port Elizabeth Bulk Terminal is located within the Port of Port Elizabeth, Eastern Cape Province. TPT has provided a graphical representation of the layout and extent of the Port Elizabeth Bulk Terminal, specifically, which can be found in **Annexure 1**. TPT requires a competent and experienced Environmental Assessment Practitioner (EAP) to explicitly outline a step-by-step, systematic approach to the entire process surrounding the Environmental requirements relating to the decommissioning and remediation of this terminal, based on an approach agreed with the authorities.

TPT is cognizant of the fact that, as a minimum, the following will be required during various stages of the decommissioning and remediation process, but needs confirmation of same, along with specific identification of further requirements and the requisite processes for each of these.

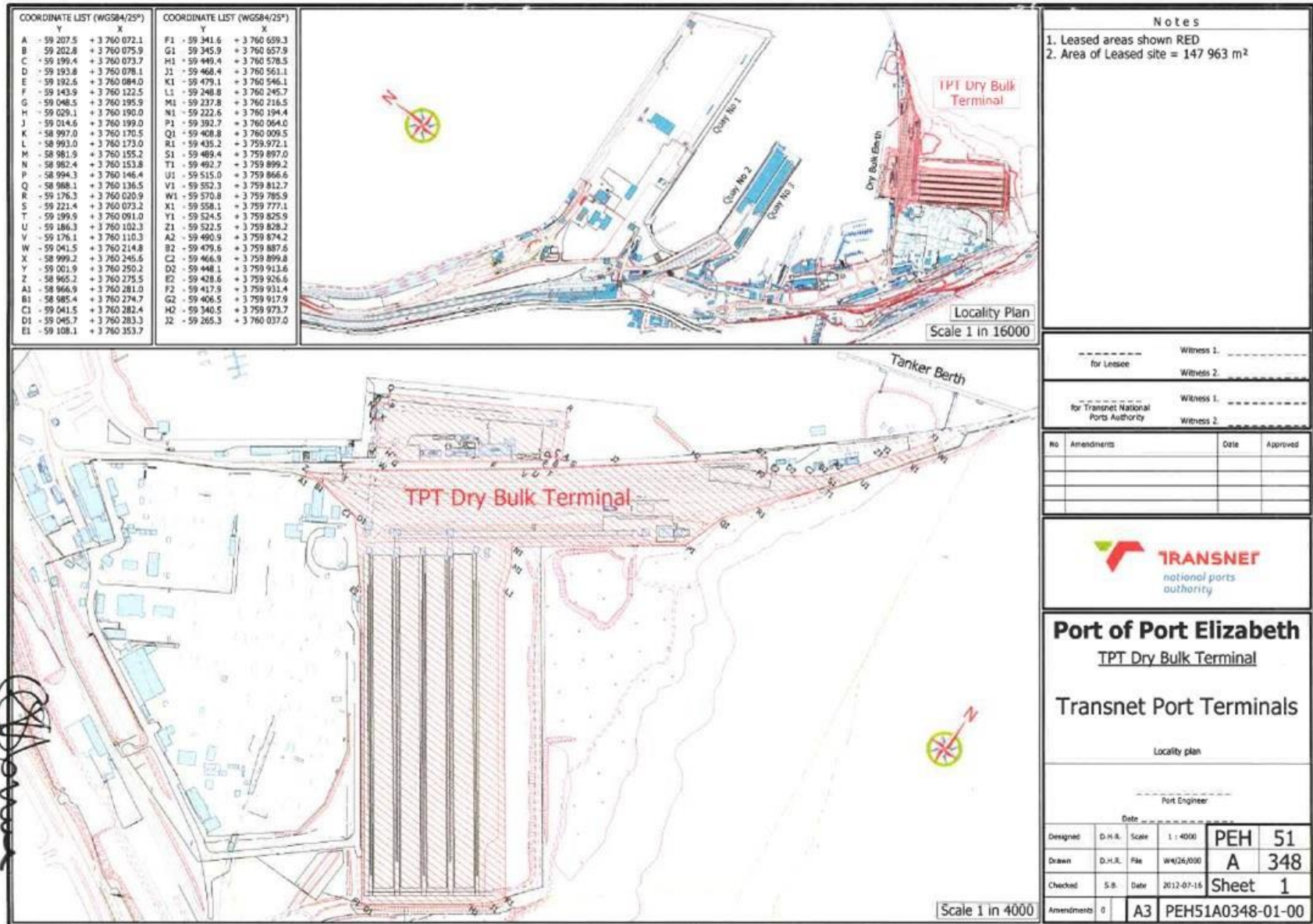
