## 1. SCOPE OF WORK

The appointed services provider is expected to provide SALGA with the following:

### 1. LLM Development and Customised SML for Local Government

To design, develop, and deploy a customisable, cloud-based multilingual Large Language Model (LLM) platform for cross-municipal processes in marketing, communication, and customer service, with multilingual capabilities.

### 2. Multilingual Capabilities

The platform must natively support at least three South African vernacular languages (over and above English)

The team must include members with proven experience in building and deploying custom AI/ML models for vernacular languages.

### 3. LG Data Integration

Enable ingestion, processing, and secure management of local government data, ensuring compliance with relevant data protection and governance standards.

Develop data flows and pipelines tailored to local language content and municipal requirements.

### 4. Model Training and Agent Customisation

Employ Gen-AI and ML models for the use of LG data and specific municipal data (across all media – i.e. text, document, audio, image, video)

Provide mechanisms for continuous improvement and adaptation of language models to evolving municipal needs – and the customisation of agents for each identified use case.

### 5. User Access and Security

Implement robust role-based access control and integration with approved security solutions. Maintain comprehensive audit trails – to ensure model explainability.

Ensure sensitive data is secured sufficiently.

### 6. Integration and Interoperability

Provide integration capabilities to connect to identified data sources – such as social media platforms, online news agencies, and other reliable and accredited data sources.

### 7. Reporting and Audit Trails

Provide technical and user training to SALGA staff and identified municipal teams on the use of the platform and/or the incremental training of the models.

## 2. BIDDER REQUIREMENTS

### 2.1 Specifications and requirements

- Demonstrate ability to develop and maintain cloud-based, multilingual AI platforms using modern frameworks (post-2019 tech stack).
- Evidence of successful deployment of AI/ML solutions for vernacular languages in South Africa or similar contexts – including using both open-source and AWS proprietary stacks.

- The bidders will be expected to demonstrate technical ability and capability to develop and maintain a *custom* model for at least three South African vernacular languages

In addition, the following principles – in line with SALGA Digital’s framework – will be expected:

- Ability to construct/customise and deploy the platform within six to eight weeks
  - Excluding project kick-off, scoping, and training

## 2.3 CV/Qualifications

- CVs/profiles of team leaders, especially with expertise in vernacular language AI/ML development.
- Lead developer must have relevant, strong qualifications/certifications in the area of Language Models. Post-graduate expertise in this environment will be critical

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

### 1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
