Nkangala District Municipality hereby invites tenders from suitably qualified and experienced service providers for Biodiversity Mapping and updating of the Nkangala District Bioregional Plan for the 2025/2026 Financial Year (Re-advert). The assignment entails conducting spatial biodiversity assessments, updating Critical Biodiversity Areas (CBAs) and Ecological Support Areas (ESAs), facilitating stakeholder consultations, and integrating ecosystem-based adaptation into the revised Bioregional Plan, in line with SANBI guidelines and applicable national and provincial frameworks. The final deliverable must be ready for municipal adoption and gazetting.

The tender documents will be available from **10 October 2025** and can be downloaded free of charge from www.etenders.gov.za. A Compulsory briefing will be held physically at Nkangala District Municipality on the **15 October 2025 at 10:00 am**.

Tenders are to be completed in black ink and completed in accordance with the conditions and rules contained in the tender documents.
