SECTION 3.1: FUNCTIONALITY EVALUATION CRITERION

Bidders must score a minimum of 70 points out of the possible 100 points in order to be considered responsive in terms of functionality.

In order to score points in respect of Experience, the bidder must attach proof **of at least 5 orders or award letters**, in support of the years in business claimed. The orders must be relevant to waterproofing work. The proof of order/ appointment letter shall not be less than R 30 000-00 in value **per order**.

Please note that references may only be provided where the work has been allocated to the bidder directly by the client, no sub-contracting work may be used for reference purposes. The **references** should complete, score and sign Form A. The original completed Form A is to be included in the tender documentation. Points for References will be allocated as indicated in the tables below and no points will be allocated in respect of incomplete or incorrect forms. Please note that the information provided will be verified by the Municipality.
