DESCRIPTION: REQUEST FOR QUOTATION TO APPOINT A SERVICE PROVIDER TO CONDUCT AN ASSESSMENT OF THE ORGANIC FOOD CHAIN; FOCUSING ON THE SUPPLY AND DEMAND, AND TO REVIEW THE FOOD RESILIENCE STRATEGY FOR THE CITY OF JOHANNESBURG.

SPECIFICATION

1. OBJECTIVE

The objective of the study/assessment is to examine the organic food chain from the producers to the consumers. The study will take into account existing networks of organic food suppliers, producers and consumer demand within the agricultural value chain in the City of Johannesburg. The study/assessment will entail the percentage and variety of the organic food produced in the region, and percentage of the total food imported into the region in order to establish the extent of the food security and distribution as well as sustainability of the CoJ urban agriculture initiatives. The final products of this study will entail a research report, which will guide and inform the food resilience strategy and its review.

2. SCOPE OF THE WORK

The study/assessment to be carried out under this contract entails assessment of the organic food supply and demand chain in all the seven regions of the city of Johannesburg. The researcher or consultant will conduct research through a mixed research methodology to collect data, analyse data, present and develop a strategy for food resilience in the City. The consultant is also expected to make recommendations and to assist the city in the review of its food resilience strategy in line with environmentally friendly practices.

2.1 Conduct the Study/Assessment (See also deliverables section 3)

- a) Conduct the study that identifies the current state of food resilience in the City.
- b) Identify ways and means to improve distribution and balancing supply, demand, affordability, resilience and quality of organic foods.
- c) The systematic literature review approach for the organic food value chain within the city of Johannesburg using large data sets. The aim of literature review is to provide a critical discussion of the existing knowledge in a field of enquiry.

- d) Collection of the related data from organization such as the Joburg Market, Department of Agriculture and Rural Development, Statistic SA, Agri – SA, NERPO, SAPO, SAPA, NAFU, Retailers and any other relevant data sources.
- e) Mapping of the network of role players (stakeholders), processes, relationships and roles in COJ agri-food chains focusing on organic produce.
- f) Write up on the assessment and develop recommendations for food resilience strategy.
- g) The assessment, recommendations and the food reliance strategy will build on existing policies, planned initiatives, City targets, and investments to inform the new food resilience strategy.

2.2 Food resiliency strategy review

- a) The consultant will use the developed brief to review the food resilience strategy.
- b) Review of the food resilience strategy will be based on assessments done and identified gaps, proposed revisions to policies and strategies; and where needed the consultant can propose the formulation of other strategies that can aid food supply and security.
- c) The service provider will adhere to the CoJ policy review processes and follow all required stages.

2.3 Period of the completion of the work

2.3.1 PHASE 1: the study /assessment should be completed within one (1) month period effective from the date of signing of the SLA.

2.3.2 PHASE 2: the review of the strategy will be based on the outcomes/recommendations from the study; and should be completed within 1 (1) months after the date of approving the final version of the study/assessment.

2.4 Location of the work

The work to be done shall cover all the regions in the city; however, the focus would be given to agricultural hubs such as orange farms, Diepsloot, Braamfisher, Ivory Park and Eikenhof etc.
