DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

The South African Broadcasting Corporation, SABC, has its Head Office in Auckland Park, Johannesburg, with Regional Offices in each South African province. SABC operates and maintains building mechanical equipment and machinery including its associated systems and facilities. The building mechanical equipment and plants needs to be maintained in good working order to ensure that they continue to offer satisfactory performance, to comply with safety legislation and to minimise disruption to normal SABC operations.

2. SCOPE OF SERVICE

This contract provides for the supply, delivery and off-loading in good condition and on the SABC's requirement regarding specified types and sizes of Mechanical and plumbing Materials/Spares/Fittings/Accessories in accordance with the specifications set out hereunder (on an as and when required basis).

The items are divided into the following categories:

CAT 1: Fasteners

This section comprises the mild steel and high tensile bolts, nuts and washers.

CAT B: Gaskets

This section comprises of the insertion rubber gaskets, and graphite gland packings

CAT C: Coupling, Pulleys and V- Belts

This section comprises of the jaw coupling, two groove pulleys to suit the wedge V-belts

CAT D: Tools and Equipment

This section comprises of items like drill bits, hacksaw blades and fitting equipment

CAT E: Bearings

This section comprises of ball bearings and tapered roller bearings

CAT F: Pipes and Fittings

This section comprises of pipe fittings like elbows, PVC & polypop, unions, traps, taps, coupling, adaptors, valves etc

CAT G: Refrigeration Items

This comprises of items such as condenser coils, fan motors, fan blades, thermostats, etc)

NB: All items must be SABS approved and all prices must include supply, delivery and offloading.

3. CONTRACT DOCUMENTATION

- Duration of the Contract- Five (5) Years.
- Location of site- SABC Auckland Park

4. RFQ RESPONSE INFORMATION

Effective Date of Bid

Vendors must state in writing in their quotation to the SABC that all provided information, including price, will be valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

5. COSTING.

The quote must include a complete cost breakdown as well as any indirect expenses related to providing the service. All bidders are urged to use the BOQ for price. ***The RFQ rates shall be fixed and shall remain firm for the first 12 months. The CPI escalation will apply from the second to the last year of the contract.***

6. EVALUATION CRITERIA

6.1 Price and Specific Goals

The RFQ responses will be evaluated on the 80/20-point system

6.2 Technical Evaluation

6.2.1 The tender submission will be technically evaluated out of 75 points.

6.2.2 A threshold of 60 out of 75 has been set.

6.2.3 **All bidders achieving less than the set threshold of 60 points out of 75 points will be declared non-responsive and therefore will not continue to be evaluated for Specific Goals & Price Preference.**

6.2.4 SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.

6.2.5 Bidder's non-compliance to this mandatory requirement will be declared non-responsive.

7. ADJUDICATION USING A POINT SYSTEM

- 7.1 The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- 7.2 Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 7.3 Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

8. POINTS AWARDED FOR PRICE

9. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

10. CONDITIONS TO BE OBSERVED WHEN TENDERING

- 10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a

separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.

10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

10.3.1 Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.

10.3.2 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.

10.3.3 Award a contract to one or more bidder(s).

10.3.4 Accept any tender in part or full at its own discretion.

10.3.5 Cancel this RFQ or any part thereof at any time.

10.3.6 Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the Specific goals & Preference Point system.

11. COST OF BIDDING

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under no circumstances be responsible or liable for any such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection process.

12. PAYMENT TERMS

1. GENERAL CONDITIONS

1.2 To be completed by the organ of state

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- 1.2 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

2 SUB-CONTRACTING

- 2.1 A person awarded a contract may only enter into a subcontracting arrangement with the approval of the organ of state.
- 2.2 A person awarded a contract in relation to a designated sector, may not subcontract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregards the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
