1. INTRODUCTION AND PURPOSE

This Quotation makes provision for the appointment of an Independent Specification Developer, an Assurance Inspection Authority on an as and when required basis for a one (1) year period.

2. BACKGROUND

- For category A and B, the Tshwane Metro Police identified the need for an Independent Specification Developer and an Assurance Inspection Authority. Goods and uniform pieces historically ordered and delivered through previous tenders did not conform to technical requirements on quality of textiles, materials and workmanship as stipulated in the previously awarded tenders. These non-compliance issues did not only compromise the over-all quality and durability of standard uniform pieces but also the protection, effectiveness and assurance associated with Personal Protective Equipment that the Tshwane Metro Police sought after and required through the award of these tenders
- The two (2) categories captured in this Board Quotation are ongoing requirements that should cater for all future needs.
- The aim of Categories A and B of this Board Quotation is to ensure that all uniform and personal protective equipment specifications are consistently updated with the newest technological advances in both the textile and personal protective equipment industries

respectively, to assure that quality, protection and guarantees relating to uniforms and personal protective equipment takes the forefront when it comes to the personnel of the Tshwane Metro Police Department.

- This project will be managed under the auspice of the Chief of Police or his/her delegated representative before services can be rendered, through the Tshwane Metro Police Department Uniform Committee, strategically located within region 3 of the Tshwane Municipal Regions within a five (5) kilometer radius of the Pretoria Central Business District (CBD).
- For category A, approvals for the amendments will be granted from the Tshwane Metro Police Department Uniform Committee.
- For category B, approvals for the evaluation and testing of samples will be granted from the Tshwane Metro Police Department Uniform Committee before the service can be rendered.
- Firstly, all Tshwane Metro Police operational members and other personnel that require official uniforms and personal protective equipment during the execution of their duties will directly benefit as quality official uniforms and personal protective equipment will be issued to members that will not require unscheduled replacement and thereby indirectly benefitting the citizens of the City of Tshwane
- Secondly, the citizens of the City of Tshwane as taxpayers will benefit directly through value for money in that the quality, durability and **effectiveness** of official uniforms and personal protective equipment required for a metropolitan police service to be rendered to these citizens, will indeed be delivered and issued to operational members rendering such services.

WHAT CONTROL AND MONITORING MEASURES ARE ENVISAGED?

- Supply Chain Management: Logistics Management (Corporate Clothing Store) will remain overall responsible for compliance with the stipulations of the MFMA and the Supply Chain Management Policy.

- For category A – Updating of specifications will be done in conjunction with the Tshwane Metro Police Department Uniform Committee.
- Category B – Assurance Inspection Authority to ensure the quality of textiles and materials. Tshwane Metro Police management and uniform depot must ensure that all operational personnel are issued with the correct uniform to perform their duties.
- Daily equipment checks lists supervised by commanders and operational managers

3. SCOPE OF WORK

This bid seeks proposals from interested prospective bidders for the appointment of an Independent Specification Developer, an Assurance Inspection Authority on an as and when required basis for a one (1) year period.

3.1 CATEGORY A:

UPDATE AND DEVELOPMENT OF SPECIFICATIONS –

This category makes provision service of a professional independent entity to maintain and update current technical specifications as well as draft and compile final technical specifications relating to existing, as well as new Tshwane Metro Police Department (TMPD)

pieces and or uniform accessories and which MUST technical illustrations on as and when required basis.

3.1.1 TECHNICAL SPECIFICATION

This specification defines the tasks to be done by the specification developer (Successful bidder) to update and develop specifications for TMPD on as and when required basis for the period of one (1) years.

The cost will vary depending on the nature off the changes as well as the extent of the changes to be done to the existing or new specification. The work and cost ranges for each scenario must be agreed upon by the Chief of Police or his/her appointed representative and the service provider before start of service. The following ranges will only be used as a guideline and can be adjusted from time to time.

3.1.1.1 MINOR CHANGES

This scenario entails minor changes to a specification where the scope of the changes is clear, e.g., specific paragraphs are to be updated or amended but no in-depth research is required to address the approved changes. The format of the specification will be updated in accordance with the specification template.

3.1.1.2 MAJOR CHANGES

This scenario entails major changes to a specification where the scope of the change is not clear and in-depth research is required to address the approved changes. The format of the specification will be updated in accordance with the specification template.

3.1.1.3 NEW SPECIFICATION

This scenario entails the development of a completely new specification documents and not an update to an existing specification. The scope of work will vary depending on the complexity of the items (e.g., sample) and access to readily available information. The format of the specification will be updated in accordance with the specification template. For this scenario, a physical sample of the item in question will be made available by CoT and or Chief of Police or his/her appointed representative TMPD.

3.2 CATEGORY B:

Appointment of an Independent SANAS Accredited Quality Assurance Services, for the City of Tshwane and Tshwane Metro Police Department for the period of one (1) year on as and when required basis.

3.2.1 PURPOSE

3.2.2 TESTING OF FABRIC

The bidder shall make use of a SANS accredited textile laboratory to conduct all textile testing in accordance with established testing methods. Competency in conducting tests in accordance with SANS test methods as well as ISO test methods are required, but not limited to it.

City of Tshwane shall have right and power to extend any Board Quotation validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalised while the quotations/bids are still valid.

8. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a Bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder if they will be able to deliver on the price, if a bidder confirm that they cannot, the bidder will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the bidder scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the Board Quotation.

 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
