It is the intention of uThukela Water (Pty) Ltd to obtain services from an Asbestos contractor that will be responsible for removal and repair of asbestos cement pipes as and when needed, within the Newcastle (Roypoint) area.

Background:

UThukela Water (Pty) Ltd Ngagane Water Treatment plant supplies bulk potable water to Newcastle, Madadeni and Osizweni Towns and surrounding areas. Some of the raw and potable water pipe network contains asbestos or asbestos related material pipe lines.

Methodology and Approach:

uThukela Water requires the services of a registered, certified Asbestos Contractor responsible for the identification, removal and repair of asbestos/ asbestos related material pipes, as and when needed.

Specifications and Scope of Work:

- Identify asbestos and asbestos related material pipe lines.
- Repair of leaks on asbestos and asbestos related material pipe lines.
- Removal, transportation and disposal of asbestos and asbestos related material pipe lines to a legal designated site.
- Submit documents confirming the correct disposal of material.
- Skills transfer through training and supervision of uThukela Water employees on the safe handling of asbestos related pipes.
